Subject: Sit Rep #101: Freedom Convoy 2022- National Capital Region 2022-01-28 to 2022-02-09

Situation as of 0847hrs on 2022-02-09

Event Overview:

- **No demonstrators** reported to be on **Parliament Hill** at this time.
- **No demonstrators on Wellington St. and in the downtown core.**
- OPS estimate that there **are 500 trucks in the downtown core.**
- Other Events:
 - o K Division:
 - Coutts POE- At 2000hrs on 2022-02-07, a group of 4 farm large farm tractors left the Coutts site northbound in the southbound lanes and blew past a checkpoint 3 (CP3) just north of the Coutts location. Members activated their lights and sirens in an attempt to stop the tractors but disengaged when it was obvious they were not stopping. The tractors eventually returned, with an additional 3 large tractors to Coutts and parked near Smugglers Saloon. Patrons of the saloon rushed out to swarm the tractors to provide a level of anonymity to the operators, and all patrons and operator returned into the saloon.
 - RCMP shut traffic S/B at CP10 overnight, and re-established traffic flow

by 0800hrs on 2022-02-08.

- During the morning of 2022-02-08, RCMP and Calgary Police investigators arrested Pastor Arthur Pawlowski for his role on February 3rd in unlawfully inciting protesters to interfere with essential infrastructure (blocking the highway). Pawlowski was charged with offences under the Critical Infrastructure Defence Act, Criminal Code (Mischief) and Breaching an existing Recognizance.
- At 1300hrs on 2022-02-08, a second farm tractor incident occurred where 6 tractors left the Coutts location and completed laps around CP3, and returned to Coutts. Again, patrons of Smugglers Saloon swarmed the occupants and escorted them back to the saloon before identifications could be established.
- Traffic flow was re-established and currently at the main site in Coutts a single lane of travel is open in each direction allowing for restricted movement of traffic.
- At the main site in Coutts currently 19 semi-trucks and 5 farm tractors are lining the northbound side of the highway 4 and 20 are lining the southbound lanes along with 5 farm tractors, for a total of 39 commercial vehicles and 10 tractors.
- At check point 10, which is set up 18km north of the main site on highway 4 the amount of protesters remain fluid. At last count there were 15 commercial vehicles, 41 RV's, approximately 108 passenger vehicles, and 9 farm vehicles.
- Coutts site is currently calm, pressure site is still CP10 where there are more vehicles and foot traffic
- Sufficient Diesel, Propane and gas stockpiled to keep involved vehicles running in cold weather at Coutts location.
- Non protest related traffic transiting Checkpoint 10 and Coutts site quickly to access Border- very minimal delays.
- Sheriff resources continue to be engaged to ensure checkpoints north of the Carway and Del Bonita POE's are active while the ports are open (both close at 2200).
- The need for heavy equipment to clear the highway of vehicles still exists and will be critical for any enforcement action.
- CCMG is still working hard with the community to develop a process to move the protesters at checkpoint 10 to an area that would allow them to have a legal protest, this would enhance police and public safety.
- Traffic is flowing, unimpeded at the time of this report (2022-02-08 in the early evening), through the border crossing in both the north and south lanes. CCMG continue to maintain communication with the organizers at both the main site and checkpoint 10.

- Kamloops, BC: On 2022-02-12 from 1030-1330hrs th Freedom Kamloops Convoy Support Rally will start off at McArthur Park with a destination of City Hall.
- Lower Mainland District:
 - Langley/Surrey, BC: On 2022-02-12 from 1000hrs, Riding the

Line (Horseback) and BC Block Party will start off at the Campbell Valley Regional Park in Langley with a destination of 176 St. Border Crossing, Langley.

- Chilliwack, BC: On 2022-02-12 at 1100hrs, the Convoy from Chilliwacks to the 176th Truck Crossing will start off on Lickman Rd. in Chilliwack and arrive at 8th Ave/176th Street.
 - Burnaby, BC: On 2022-02-19 from 1000-1500 hrs the Freedom Convoy to Global News Rally will start off at the Colossus Cineplex Cinemas in Langley with a destination point of Global News at 7850 Enterprise St. in Burnaby.
 - Chilliwack, BC: On 2022-02-21 at 1100 hrs, the Family Day Rally/Convoy Supporting Truckers will start off on Lickman Rd and travel to Townsend Park in Chilliwack.
 - Vernon, BC: Ongoing since 2022-02-04, the Free the North, Park and Protest remains ongoing Monday to Friday from 0900hrs-1600hrs at the Office of MLA SANDHU. Plans are that this will continue until mandates are lifted.
 - Vancouver Island, BC: On 2022-02-12 starting at 0645hrs the Island Convoy will travel from Campbell River to the BC Legislature in Victoria, BC.
 - Victoria, BC: On 2022-02-08 from 1330hrs-1530hrs the Stay Victoria Convoy engaged in a rolling convoy around the Legislative Assembly of BC.
 - 100 Mile House, BC: On 2022-02-18 at 0900hrs and on 2022-02-19 at 1200hrs, there 100 Mile Slow Roll will take place, starting at Exeter Truck Rd through to the intersection of Hwy 97 and 24.
 - Fort St. John/Dawson Creek, BC: On 2022-02-09 from 0730hrs-0900hrs, the Peace Country Convoy 22 will leave from Fort St. John and travel to Dawson Creek, with a planned destination of Ottawa, ON.
- CBSA has reported the following statuses of crossings into Canada:
 - As of 0714 hrs: Ambassador Bridge (Windsor) temporarily closed. Windsor Tunnel remains open.
 - As of 0643 hrs: Blue Water Bridge (Sarnia) – delays of 4 hours 15 minutes.
 - As of 0710 hrs: Peace Bridge (Niagara Region) – delay 5 minutes.
 - As of 0430 hrs: Coutts, AB – 1hour delay.

Operational Information:

- A Facebook event page titled: *Blue-collar Convoy 2022 West Route* was located. According to the event page, the group will be meeting at the Canadian Tire Center at

0900hrs on 2022-02-13. The convoy will make its way down the Queensway, and end their convoy on Kent Street in downtown Ottawa. The event page has received minimal online engagement (2 going, 55 interested). The event page was created by the Facebook group *Blue-collar Convoy 2022*.

- An Instagram user, @diagolonneverdies, has made a series of posts calling for violence against law enforcement and the general public on 2022-02-07.
- On 2022-02-07, @diagolonneverdies posted “Let’s hunt some circ...” alongside a picture of a FREEDOM CONVOY 2022 protester being arrested by law enforcement. “Circ” likely refers “Circulon,” a word used by followers of the PLAID ARMY/DIAGOLON to denote those that do not support their political beliefs.
- On 2022-02-07, prior to the above post, @diagolonneverdies made another post stating, “One idiot cop like this is going to make this problem a whole lot worse if they keep this crap up.”^[iii] This post also appears to have been made in reference to the arrest of a protestor.
- A statement from @diagolonneverdies on 2022-02-06 (post mentions two days ago) references an individual named
... Let’s do it, sanctioned, in a ring.”^[iv]
- @diagolonneverdies is likely the same user behind the Instagram account @ferrymans_toll, who was previously identified by CIG OSINT walking with Jeremy MACKENZIE looking to ^[v] Images from the accounts of @diagolonneverdies and @ferrymans_toll both depict an individual donning an identical black hat with the Diagolon stripe, along with a white facemask.
- The moniker “The Ferryman’s Toll”, which is similar to @ferrymans_toll, has been linked in open sources to “Alex Vriend”.^[vii] Vriend is allegedly a member of the DIAGOLON and its related PLAID ARMY movement.^[viii] VRIEND is also known to be an associate of Jeremy MACKENZIE.^[ix] The website, anti-hate(.)ca, claims that Vriend has previously urged violence at protest events.
- OPS and CBSA assisted in identifying the individual as Alexander VRIEND. CIG has provided OPS with the information for further action if required.
- PPS identified on an open source Instagram account belonging to a supporter of Diagolon (possibly Alex VRIEND) posting possible leaked information from the City of Ottawa detailing chartered buses transporting support police staff from other jurisdiction.
- As per CIG Update #105, CIG OSINT located a Twitter post by MPP Randy HILLIER, posted at 1915hrs on 2022-02-07, where HILLIER appears to be promoting and possibly organizing a convoy of trades and construction workers. HILLIER indicates that details are pending.
- HILLIER interview with Russian state-owned media:

- Randy HILLIER appears to have uploaded an interview with RT, a Russian state-owned media on 2022-02-07, on the website odysee(.)com. The video was possibly uploaded on 2022-02-07.
- In the interview, HILLIER speaks against COVID-19 measures and derides the Government of Canada and Prime Minister Trudeau for spreading “propaganda” as a means of destroying constitutional rights. HILLIER also speaks out against the GoC for what he perceives are attempts to discredit the Freedom Convoy 2022.
- RT has been commonly identified as a Russian state-funded and state-directed media source. (e.g. <https://www.state.gov/report-rt-and-sputniks-role-in-russias-disinformation-and-propaganda-ecosystem/>)
- The full video has been captured by CIG Open Source.
- On 2022-02-08, OPS received information that [REDACTED] sent an email stating that the user, possibly [REDACTED] is in the process, along with Randy Hillier, of organizing a convoy of trades’ people to drive to the Hill from three staging areas this Sunday.
- Citizens advised RCMP members located at Portage Bridge in Gatineau that some of the protesters were hiding gas cans “inside” a snow bank at Portage Bridge.
- **FPNS Task Force:**
 - **Reviewed CIG Updates:**
 - #108, 109 and 110 for NS concerns;
 - No concerns identified.
 - PROS: 2022-165473:
 - File generated to conduct checks on [REDACTED] in relation to Wilful Promotion of Hatred. [REDACTED] has been making repeated social media videos and posts with racist connotations, and also implying violence towards the Government of Canada. Ottawa INSET on-call advised, and TIOS has been asked to capture all of the posts. FPNS is monitoring.
 - PROS – 2022-165358:
 - File generated for [REDACTED] relating to his breaching his release conditions. Members confirmed the release conditions with [REDACTED] OPS is also aware of the possible breach conditions, and their investigative units will deconflict with RCMP as required. FPNS is monitoring.

Operational Planning:

- Nil updates at this time.

Protective Clients and Protective Sites:

- All protected clients will be in the NCR today, with regular escorts.
- PRU conducted increased patrols at the various protected sites and residences, no issues to report.

Communications:

- According to a social media post from this morning, one of the organizers is discussing the protestors in Ottawa leaving and heading for Toronto. While following up on an afternoon press conference, Ottawa Police noted that the situation in the downtown core has been made more complicated by the presence of several children in the area, making an intervention difficult. Articles also touched on the economic impact of these protests, particularly at the Ambassador Bridge, where over \$400 million worth of goods cross each day.
- A request was received from CNN regarding this morning a video post on Facebook about police removing gas cans from the protest site. The reporter has been referred to the OPS.

Hi Brigitte and Michele,

Apologies for emailing you so late in the evening but I wanted to provide you with an update on where we are at with this request.

I had the opportunity to review the document. The document is well written and is very informative. The first few pages are an overview of the author's credentials and then up to page 16, the author provides an overview of RWE in Canada. Pages 16 to 18 outlines the impetus, origins or development and evolution of the border blockades and protests that occurred in early 2022 in various parts of Canada (identified by participants as the Freedom Convoy 2022). In my opinion, FPNS does not require to review the above pages.

Upon review of the other sections of the paper, there are elements in the paper that falls within the NS mandate. I don't believe that any of the information in these sections that are inherently sensitive or problematic. However, can FPNS please review the following sections to confirm this determination. The sections/pages are as follows:

- Who were the participants and leaders, if any, in the groups? (pages 18 to 21 – reference made to subjects known to FPNS)
- What was the nature of this movement? What, if anything, changed over the course of the movement? Were there any organized groups that participated in the blockades and protests? (Pages 21 to 23 – reference made to the flags).
- Online connection (pages 23 to 25)
- What can be said, if anything, about domestic and/or international connections to other far right actors or protests, including in the U.S.? (pages 25 to 28)

As well, Loretta will also send the report to FPNI first thing in the morning for their review due to IMCIT's role in this space.

I advised Loretta that FPNS would be able to review the document first thing in the morning and we would strive to provide her with a response by 9:30 am tomorrow morning. This way, we don't have to further disturb someone this evening.

I have a few comments that I'm not sure they're appropriate to share given they're outside our remit but if it ever comes back on us

- 1) Why is this Pro B? It's all OSINT. I understand IMCIT has made an assessment based on their understanding/review of material but if anything I would think that would make it Pro A, not B.
- 2) As per RCMP intel writing guides, each paragraph should have classification. I think this would be especially important when sharing beyond RCMP to ensure information is properly safeguarded.
- 3) The estimative/likeliness language is not something I've seen before in intel reports (i.e. IMCIT assesses). What does that mean? There is an agreed upon "estimative language" scale that DND uses that RCMP has informally adopted (available on the Aide Memoire for int analysts). As an intel community, we should be striving for consistency, especially on topics like that that several program lines including FPNS also cover/brief on.

Canadian Freedom Convoy

- The Freedom Convoy rolled into Ottawa from 2022-01-28 to 2022-02-20. During the duration of the Freedom Convoy, different anti-government/anti-authority groups/individuals were observed taking part in several protests/blockades activities in Ottawa. Other protests/blockades aligned with the Freedom Convoy took place simultaneously in other Canadian Provinces.
- On 2022-02-06, Ottawa Mayor Jim Watson declared a State of Emergency. Following this announcement, the RCMP Federal Policing National Security established a Task Force with the mandate to assess Convoy related information for any threat to national security and action appropriately; and analyze all available information against current FPNS holdings and ongoing NS investigations to identify any possible connections.
- The *Emergencies Act Measures* was declared by the Federal Government on 2022-02-14 to give the Government of Canada temporary powers to address the illegal occupation against pandemic restrictions. On the same day, the RCMP made a significant seizure of firearms and ammunitions in relation to the Coutts blockade in Alberta.
- The DIAGOLON movement and community, an anti-authority/anti-government group, was exposed prior to the Freedom Convoy but gained popularity during the protest. DIAGOLON patches found on a tactical vest of a main subject of interest was seized during the arrests at Coutts blockade along with 12 firearms with a large amount of ammunition.
- To this date, the RCMP is still investigating the DIAGOLON movement's presence in Canadian Provinces.

A guide for committing attacks began circulating among the loosely affiliated network of accelerationist neo-Nazi channels and groups known as Terrorgram on June 1, 2022. The guide discouraged attacks like the May 14, 2022 supermarket shooting in Buffalo, New York, in favor of "big-picture" attacks "that do the most damage to the system and spark revolution and chaos." Specifically, the guide focused on attacking power grids and assassinating "high up system pig[s]" in order to "create ... the greatest shock and outrage." At the guide's conclusion, the unknown author called on accelerationists to "target Jewish think tanks" and included references to Chuck Schumer and the Anti-Defamation League (ADL).

MC and I have finished our review. Our comments are annotated in the document, but I will give some context here;

General Comments

- This is obviously not a paper written in our style. At 22 pages, it lacks the brevity that we aim for. We didn't spend too much time on that because stylistic differences between units are natural and NSOA is the client/audience so we can obviously take in much larger reports than an INSET/NSES investigator.
- We generally agree with the Key Assessments, 1) DIAGONON is led by MACKENZIE, 2) based on current information, DIAGONON does not meet dictionary definitions of a group (ops data could change this), 3) the rhetoric associated with this movement/idea could inspire lone actors or small groups to violence, 4) there is evidence that DIAGONON has gained real-world traction.

What is accelerationism?

Working definition:

A set of tactics and strategies that are designed to put pressure on latent social divisions, exacerbate them, and ultimately cause runaway chain reactions of social upheaval that lead to large-scale destruction of political, social, and cultural systems.

Tactics can include political activism, “metapolitics,” and streetfighting, but emphasis is on “apolitical” terrorism.

Global accelerationist *movement*: Mostly neofascists, but not exclusively

Main characteristics:

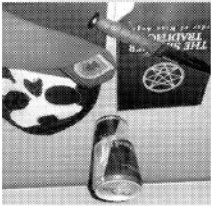
- Hostility toward modernity
- Nihilistic outlook on civilization and political systems
- “There is no political solution”
- Apocalyptic: desires destruction, usually for the purpose of metaphysical rebirth
- Focus on exploiting existing contradictions and divisions within society

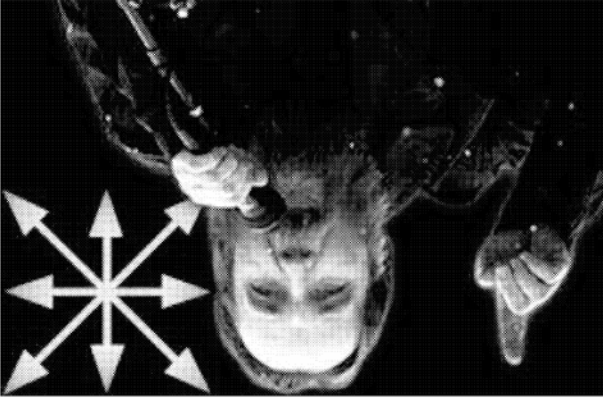
- Left-Hand Path occultist pathway

- Linked to terrorist attacks and murders throughout world



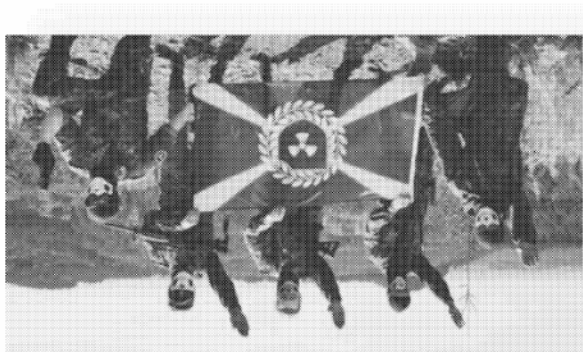

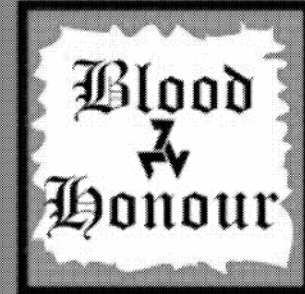
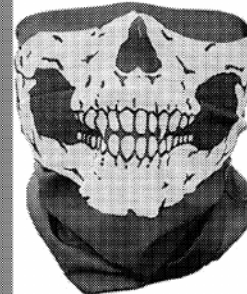
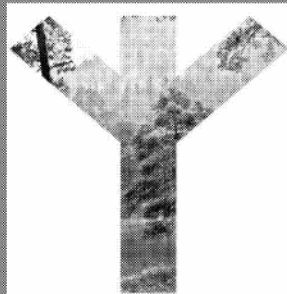
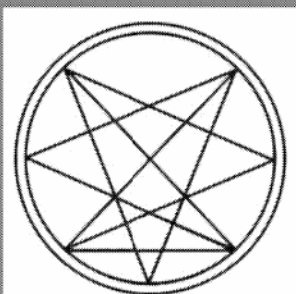
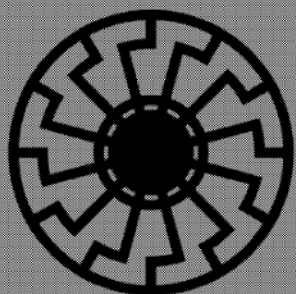
New Developments

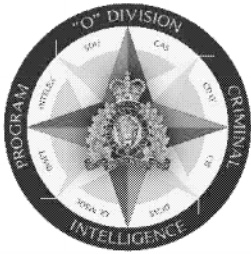

AIM

To provide an update on individuals, groups or movements that may pose a risk to commit acts of violence in support of an ideological objective in the lead up to the 2021 Canadian Federal Election.

KEY FINDINGS

- Jeremy MACKENZIE is known to the RCMP and
- MACKENZIE is the founder of the fictional country of DIAGOLON and likely the source of DIAGOLON flags that have appeared at multiple protest events held during the 2021 Federal General Election campaign.
- MACKENZIE is a former Canadian Armed Forces (CAF) combat veteran who has a significant following on social media where he advocates against COVID-19 lockdowns and what he views as a larger conspiracy to use vaccines and the media to seize power and disenfranchise white Canadians.
- In April 2021, MACKENZIE made an indirect threat about setting fire to the Parliament. He has also allegedly espoused anti-Semitic conspiracies, Holocaust denial, and disparaged Jews and Muslims.
- No specific threats have been observed related to the election. However, it is possible that individuals may be inspired by MACKENZIE's anti-government and xenophobic rhetoric to conduct independent action.

ISSUE

Ottawa INSET was tasked with conducting an intelligence probe of incidents targeting the four (4) primary political parties in Canada, as well as Ministers and VIPs involved in the election campaign. The objective is to identify criminality potentially falling under the INSET's national security mandate. Specifically, the formation of a coordinated group that intends to commit acts of violence in support of an ideological objective.

ANALYSIS

A review of election related incidents revealed multiple occurrences involving Jeremy MACKENZIE and individuals in possession of flags associated with the fictional country of DIAGOLON.

DIAGOLON

The DIAGOLON flag has been observed at multiple protest events held during the 2021 Federal General Election campaign. Jeremy MACKENZIE (DOB: [REDACTED] also known as the RAGING DISSIDENT, is the founder of the fictional country of DIAGOLON, which is composed of territory that runs from Alaska to Florida on a diagonal axis across Canada. According to MACKENZIE, the fictional country includes parts of British Columbia, Alberta, and Saskatchewan but would exclude cities such as Vancouver and Abbotsford for “obvious reasons.”ⁱ



MACKENZIE claims he created the DIAGOLON flag, which features a white diagonal line across a black background, using Microsoft paint on his cell phone.ⁱⁱⁱ The DIAGOLON flag and other related merchandise is available for sale on RAGING DISSIDENT’s online store on Redbubble.com.^{iv}



On 2021-09-05, unidentified protesters near a Liberal Party of Canada (LPC) campaign event at the CACHET SUPPER CLUB located in Newmarket, Ontario were observed waving a black flag with a white diagonal line. There were no confirmed reports of any physical violence involving the individuals in possession of the flag.^{vi}



On 2021-09-09, a black flag with a white diagonal line was observed outside of the English language debate located at the Museum of History in Gatineau, Quebec. The unidentified male holding the flag was wearing a plaid shirt and described himself as a former veteran and member of a group called RAGING DISSIDENT. There were no confirmed reports of any physical violence involving the individual in possession of the flag.^{viii}
