

JEREMY MACKENZIE

MACKENZIE is known to the RCMP and i

MACKENZIE is a former CAF combat veteran and served one tour in Kandahar, Afghanistan in 2007 prior to being released in May 2017.

The Canadian Anti-Hate Network describes MACKENZIE as a prominent member of the PLAID ARMY<sup>xii</sup> and advocate against COVID-19 lockdowns, which he views as a larger conspiracy to use vaccines and the media to seize power and disenfranchise white Canadians.<sup>xiii</sup> MACKENZIE gained notoriety in February 2020 after protesting at an event in Halifax featuring a speech by Omar KHADR. At the event, MACKENZIE expressed displeasure with the Government of Canada's apparent lack of support for veterans and the large monetary settlement paid to KHADR.<sup>xiv</sup>

MACKENZIE has a significant social media presence with an estimated 46,000 followers (as of July 2021) and is active on at least twelve (12) social media platforms.<sup>xv</sup> MACKENZIE produces a daily podcast under the pseudonym RAGING DISSENT that regularly touches upon politics, COVID-19 policies, and vaccine mandates. On 2021-09-01, MACKENZIE appeared on the Alex JONES Show (of INFOWARS.com) where he espoused various conspiracy theories related to COVID-19 and Afghanistan.<sup>xvi</sup> The Anti-Defamation League (ADL) describes JONES is a well-known "right-wing American radio host and prolific anti-government conspiracy theorist."<sup>xvii</sup>



On 2021-07-25, People's Party of Canada (PPC) leader Maxime BERNIER reposted one of MACKENZIE's Instagram videos in which he expressed his disdain for the apathy among the general public with respect to contesting existing COVID-19 policies.<sup>xviii</sup>



On 2021-04-16, the Canadian Anti-Hate Network published a story alleging that MACKENZIE claimed there was a race war underway in America and used language consistent with the accelerationist ideology. During a podcast titled "Step on the Gas, Accelerate," MACKENZIE allegedly said: "Accelerate, accelerate, there's no way out. This is going to come to total shit, so let's just get it over with. If you're going to be in a fight, hit first, Vladimir Putin said that."<sup>xx</sup>

During the same episode, MACKENZIE made an indirect threat about setting fire to the Parliament. "I'm this close to deciding, you know what, let's just burn everything down. Let's just go to Parliament Hill and burn it down. Let's just burn all of it down. Because they don't care anymore. This is how life is going to be is it? It is going to be this difficult and irritating every which way you turn you're going to have difficulty, fucked with." The RCMP (POCC) investigated the statement and deemed it to be non-criminal.<sup>xxi</sup>

On 2020-02-14, Anti-Racist Canada published an article claiming that MACKENZIE regularly espouses anti-Semitic conspiracies, Holocaust denial lines, and disparages Jews and Muslims, in addition to promoting hate literature. "On Twitter, he has claimed "You can't vote your way out of this...the only viable solutions are illegal and I'd be jailed publically [sic] for saying them."<sup>xxii</sup> Also worth noting, MACKENZIE promoted the book "The Day of the Rope" written by Devon STACK.<sup>xxiii</sup> The fictional book is heavily influenced by the QAnon conspiracy theory and is centred around a shadowy cabal of wealthy elites in control of society. At the conclusion of the book, the elites and non-whites are massacred and replaced by a white ethno-state.<sup>xxiv</sup> The book is considered a modernized re-imagining of The Turner Diaries written by William PIERCE.<sup>xxv</sup>

*Analyst note: The ADL describes the Day of the Rope is a white supremacist concept taken from the Turner Diaries, a fictionalized white supremacist revolutionary novel written in 1978 by neo-Nazi William PIERCE. The slogan has become popular among white supremacists and was used in propaganda distributed by Atomwaffen Division in the United States.*<sup>xxvi</sup>



## CONCLUSION

No specific threats have been observed related to the election. However, it is possible that individuals may be inspired by MACKENZIE's anti-government and xenophobic rhetoric to conduct independent action. Consideration should be given to

## **BACKGROUND :**

- This Ops Brief pertains to the investigations and the coordination of our efforts in regards to the Diagonlon ideology, Coutts investigation/ties, Freedom Convoy et al.
  - The Plaid Army, a neo-fascist group that wishes to stage a violent revolution to establish a new “Diagonlon” – a country joining the Canadian West with parts of the United States with acceleration fantasies has often celebrated the convoy’s protest and ongoing occupation in Ottawa. The group, which is ostensibly led by Jeremy Mackenzie (a Nova Scotia-resident) attempted to create a network of localized groups.
  - A number of adherent to the group and it’s ideology surfaced during the protest.
  - Jeremy Mackenzie aka Raging Dissident has been in Ottawa to attend the protests. He is believed to be in the Ottawa region at the moment.
  - Jeremy Mackenzie was arrested earlier this year in Nova-Scotia in January and a search warrant was executed where a number of firearms and firearms illegal magazines where seized. He was release under conditions, including not to be in possession of firearms.

## **CURRENT STATUS :**

- On February 15<sup>th</sup>, 2022 FPNS consulted with K-INSET Calgary and it was determined that they had more then a reasonable suspicion or belief that criminal activity has occurred or will occur and had enough information to begin an investigation pertaining to the Diagonlon ideology/Plaid Army, mainly based on the linkages emanating from the Coutts File.
  - It is expected that all the evidence and data set from the Coutts file will be transferred to K-INSET. The timeline for this has not yet been established.
- This file will allow a coordination of efforts since it has come to light that numerous POJ’s and different divisions have undertaken their own separate efforts and investigation in a silo fashion directly correlated to the Diagonlon ideology and Plaid Army. adherents. One of the objectives of this file will be the centralization of information to facilitate a holistic approach to this ideology and its members to determine if this ideology is criminal in nature while liaising with partner agencies, particularly municipal and provincial police services, to develop relationships and networks to ensure effectiveness.
  - Several files have been undertaken either prior to the Freedom convoy or has a result of the convoy. Therefore not to duplicate the effort

**Background:**

The RCMP is currently deployed at the Canada – U.S. border crossing near Coutts, Alberta, as a result of an organized protest by truckers against COVID-19 vaccine mandates and this file is about the general blockade / protest at this location.

K-Div Serious Crime Branch (SCB) General Investigation Section (GIS) began a major UCO operation in regards to criminal activities of mischief over 5000\$ toward the organizers of the blockade/protest in order to gather intelligence/evidence as to hierarchy and plan. During the UC operation, information was obtained regarding individuals who made comments about having access to a stockpile of hundreds of guns and thousands of ammunitions. Based on the totality of the circumstances, the undercover officers believed that they are in possession of firearms and ammunition.

On February 11, 2022, an interception pursuant to section 184.4 of the *Criminal Code* to prevent imminent harm to police was obtained.

The investigation is in evidence gathering stage, with investigators seeking an Authorization to Intercept Communications, and related Orders and Warrants, in order to intercept the communications of involved individuals. The offences being investigated include:

- Weapons trafficking, contrary to section 99 of the *Criminal Code*;
- Conspiracy to traffic weapons, contrary to section 465(1)(c) of the *Criminal Code*;
- Mischief over \$5,000, contrary to section 430(3) of the *Criminal Code*;
- Conspiracy to commit mischief over \$5,000, contrary to section 465(1)(c) of the *Criminal Code*.

Calgary K-INSET investigators are now involved in the GIS investigators in assistance for the IMVE point of view. SCB-GIS (K-Div) will remain the lead unit in this investigation.

**Current Status**

- In the late evening on February 12, 2022, intelligence was obtained from an officer/public safety perspective in relation to comments made by an individual

- Search warrant and arrest were made on February 14, 2022.
- SCB GIS executed a search warrant at \_\_\_\_\_ in Coutts, Alberta for Mischief Over \$5000, in the early morning of February 14, 2022. The warrant included the residence, outbuildings and trailers on the property.
- In total 12 rifles, 1 shot gun, 2 pistols, and large amounts of ammunition were located. An unloaded handgun with laser sight was seized, along with loaded magazines.
- The following individuals have been charged with Possession of a Weapon for a Purpose Dangerous to Public Peace (s.88(1) CC), Mischief by willfully obstructing the lawful use of Highway 4 at or near Coutts land border the value of which exceeded \$5,000 (s.430(3)CC);

- On February 14, 2022 interviews were conducted with all persons arrested.

- On February 14, 2022 Jerry Morin, was arrested during a traffic stop outside High River, Alberta. Two shot guns were located in the vehicle upon his arrest. ### ISSUE:

- The RCMP is currently deployed at the Canada – U.S. border crossing near Coutts, Alberta, as a result of an unlawful protest against COVID-19 vaccine mandates. The RCMP is addressing public safety concerns and ensuring that the protest remains peaceful. However, because the protestors are using trucks to completely prevent traffic from going through the border on both sides, the RCMP is also engaged in a criminal investigation into the offences of Mischief over \$5,000, and Conspiracy to commit Mischief over \$5,000.

### BACKGROUND:

- The investigative team is utilizing a number of investigative techniques.
- Intelligence collected identified public / officer safety concerns which included a reference of access to a stockpile of weapons consisting of hundreds of guns and thousands of rounds of ammunition.
- 2022-02-11, authorization to intercept communications pursuant to section 184.4 of the *Criminal Code* to prevent imminent harm to police was obtained.
- Investigators obtained a section 186 Authorization to Intercept Communications, and related Orders and Warrants. The offences being investigated included:
  - Weapons trafficking, contrary to section 99 of the *Criminal Code*;

- Conspiracy to traffic weapons, contrary to section 465(1)(c) of the *Criminal Code*;
- Mischief over \$5,000, contrary to section 430(3) of the *Criminal Code*;
- Conspiracy to commit mischief over \$5,000, contrary to section 465(1)(c) of the *Criminal Code*.
- Calgary INSET investigator attended the Coutts border location on 2022-02-11 and met with Serious Crime Branch GIS investigators.
- INSET supported and monitored the investigation from a National Security perspective.

**CURRENT STATUS:**

- SCB GIS executed a search warrant at \_\_\_\_\_ in Coutts, Alberta for Mischief Over \$5000, in the early morning of 2022-02-14. The warrant included the residence, outbuildings and trailers on the property.
- In total 12 rifles, 1 shot gun, 2 pistols, and large amounts of ammunition were located. An unloaded handgun with laser sight was seized, along with loaded magazines.

- Chris Corbert, Chris Lysak, (Anthony) Tony Olienick, Jerry Morin have also been charged with Conspiracy to Commit Murder of Police Officers (s.465(1)(a).

- On February 14, 2022 interviews were conducted with all persons arrested.

**NEW INFORMATION**

*Key points shared during the OPP Intelligence Partners Conference Call on 2021-01-25 at 1300hrs:*

- On 2022-01-25, Regina PS advised that the convoy consisted of approximately 1200 trucks.
- At 1100hrs the OPP was advised by organizers (unconfirmed information) that a total of 1600 vehicles were part of the convoy. Of those about 162 are tractor trailers, the rest are personal vehicles.
- Some smaller vehicles and cars have been joining in the convoy but have turned back at the end of the day.
- Indications have been identified that suggest that trucks from the US may be joining in the convoy.
- There is online chatter from participants surrounding the idea that TRUDEAU may try to stop the convoy by setting up blockades, and has requested the assistance of the military. There is no indication at this time that there are any attempts made to slow down or stop the convoy. However, this type of chatter may fuel tensions.
- There appears to currently be two groups within the convoy:
  - The truckers: Want a peaceful event.
  - Supporters and non-truckers: Some from various anti-government, anti-vax, anti-mandate, COVID denialism movements who may cause disturbances.
- There are indications that the group *Diagolon* will participate in this event. This group came up during the 2021 Federal Elections. The Canadian Anti-Hate Network has indicated *Diagolon* is increasingly becoming a militia network.
- Increase in online chatter which incites violence. References to the current situation in Belgium and the Capitol event in the US.
- Social media users have made posts related to the possibility of blocking main stream media from using their vehicles to try and report at the demos or around the convoy. The group wants to control the narrative.
- Although organizers have repeatedly mentioned that this is a peaceful movement, it is doubtful that due to the size of the convoy, that they will be able to control the actions of all participants.

- OSINT suggests that a group of roughly 2,000 people from Quebec is expected to park on the Gatineau side and walk over to Ottawa on 2022-01-29.
- OPP will be setting up at the Manitoba-Ontario border.
- Organizers have advised OPS that they will be setting up QR codes associated to road captains.
- 3600 people are expected to cross the bridge in Gatineau, QC into Ottawa on 2022-01-29.

*Information from Open Source research (2022-01-26 @0700 hrs):*

- The GoFundMe page currently sits at over \$5.1 million.<sup>1</sup>
- According to a Facebook live video posted to the Freedom Convoy 2022 page on 2022-02-25, the group ended their day in Kenora, ON. The convoy also received a police escort from the OPP once they got into Ontario.
- Various social media posts referencing TRUDEAU being at the “cottage” have been identified.<sup>2</sup>
- Social media posts indicating that trucks from the US will be joining the Canadian convoy. On post of concern indicates that the convoy will be joined by “Americans who were responsible for the January 6<sup>th</sup>, in Washington. Most will try to bring guns across the border and some will succeed”.<sup>3</sup>
  - This information could not be confirmed through open sources at this time.
- The Facebook group *Convoy to Ottawa 2022*, which had over 600,000 members, appears to have been shut down. The group has started a new page: *Convoy to Ottawa 2022 Restart*<sup>4</sup>. The shutdown of the Facebook page has raised tensions as many members believe that TRUDEAU requested for the page to be removed.<sup>5</sup>
- The group is expected to leave Kenora, ON (470 Lakeview Dr, Kenora, ON P9N 0H2) at 0900hrs and is expected to end their day in Thunder Bay, ON (3131 Arthur St W, Thunder Bay, ON P7C 4V1) at 1600hrs.<sup>6</sup>

## ASSESSMENT

Open source research has identified various posts and comments from social media users which incite violence and unlawful activity. Social media posts indicating “TRUDEAU we are coming for you” and “storm Parliament” have been identified. Some individuals have also mentioned the possibility that the convoy will be blocked or slowed down. This type of dialogue could raise tensions within the convoy.

The main organizers of this event have repeatedly stated that this will be a peaceful event, however, due to the size of the event, it is likely that organizers will be unable to control the actions of all participants.

The details surrounding the demonstration which is expected to take place on 2021-01-29, once all the convoys have converged into Ottawa, still remain unclear. The route details all end on Parliament Hill, however, it is unknown at this time if the group will remain on Parliament Hill for the entire duration of the demonstration or if they will be making their way to other protected sites. Although the organizing group has not made any mentions of attending other locations, social media posts indicate that there is

a possibility that groups may attempt to cause disruptions in the vicinity of 24 Sussex Drive, the Official Residence of the Prime Minister of Canada. Of note, PM TRUDEAU and family do not reside at this location.

Of note, some social media users have suggested that demonstrations be organized in the vicinity of Harrington Cottage. Although no actual plan has been identified at this time, the possibility that demonstrations will take place at this location cannot be fully discounted.

## RECOMMENDATIONS/NEXT STEPS

Due to the extensive amount of information being shared to social media each day, the PIU will continue to monitor the *Freedom Convoy 2022* through open sources. Updates will continue to be provided as new information is identified.

FYSA quick update for your side. A more comprehensive read out/transcript should be done, however this will likely take some time. We can look at getting raw material if required.

- On March 16<sup>th</sup> 2022, F-NSES members assisted by C-INSET members met at the MRC des-Collines Police Station where they conducted an interview of a witness. The witness statement lasted approximately 2.5 hours. During this time the witness was able to cover the following topics:
  - An overview of the Diagonon movement, its origins, ideology, the significance of the flag, and activity and membership across the various provinces;
  - A history of Suspect (SUS) past travels and criminality;
  - Persons of significance to the movement both online and in person;
  - An overview of the movement's online presence;
  - Previous gatherings of the movement;
  - Persons within the movement who have access to firearms – including restricted and prohibited devices;
  - SUS connection to the Coutts investigation;
  - Name of a law enforcement member who was active in the group;
  - SUS connection to the Ottawa protests;

- Of note the witness apparently possesses a collection of electronic evidence which is believed to be potentially useful to police and has made an offer to voluntarily give it to police. This will be explored.

- An Instagram user, @diagolonneverdies, has made a series of posts calling for violence against law enforcement and the general public on 2022-02-07.
- Approximately 19 hours ago, @diagolonneverdies posted “Let’s hunt some circ...” alongside a picture of a FREEDOM CONVOY 2022 protester being arrested by law enforcement. “Circ” likely refers “Circulon,” a word used by followers of the PLAID ARMY/DIAGOLON to denote those that do not support their political beliefs.<sup>[i]</sup>



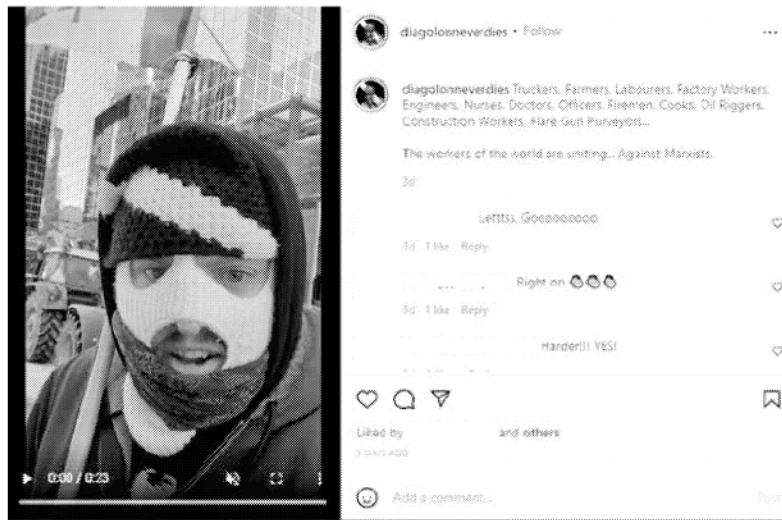
- Approximately 1 day ago, @diagolonneverdies made another posts stating, “One idiot cop like this is going to make this problem a whole lot worse if they keep this crap up.”<sup>[iii]</sup> This post also appears to have been made in reference to the arrest of a protestor.
- A statement from @diagolonneverdies approximately two days ago references an individual named \_\_\_\_\_, stating, \_\_\_\_\_ ... Let’s do it, sanctioned, in a ring.”<sup>[iv]</sup>

- The moniker “The Ferryman’s Toll”, which is similar to @ferrymans\_toll, has been linked in open sources to Alex VRIEND.<sup>[vii]</sup> VRIEND is allegedly a member of the DIAGOLON and its related PLAID ARMY movement.<sup>[viii]</sup> VRIEND is also known to be an associate of Jeremy MACKENZIE.<sup>[ix]</sup> The website, anti-hate(.)ca, claims that VRIEND has previously urged violence at protest events.<sup>[x]</sup>

#### **ADDITIONAL INTEL UPDATES:**

- CIG OSINT has located a Twitter post by MPP Randy HILLIER, posted at 1915hrs on 2022-02-07, that suggest that he is promoting and possibly organizing a convoy of trades and construction workers. HILLIER indicates that details are pending. On 2022-02-8, OPS received an email from [redacted] stating that he is in process along with Randy Hillier of organizing a convoy of trades’ people to drive to the Hill from three staging areas this Sunday.
- RCMP members were advised by citizens that some of the protesters were hiding gas cans “inside” a snow bank at the Portage Bridge in Gatineau, QC.

- PPS identified on an open source Instagram account belonging to a supporter of Diagonon (believed to be Alex VRIEND) posting possibly leaked information from the City of Ottawa detailing chartered buses transporting support policing staff from other jurisdiction.<sup>[xi]</sup>

  - In the interview, HILLIER speaks against COVID-19 measures and derides the Government of Canada and Prime Minister Trudeau for spreading “propaganda” as a means of destroying constitutional rights. HILLIER also speaks out against the GoC for what he perceives are attempts to discredit the Freedom Convoy 2022.

  - The full video has been captured by CIG Open Source.

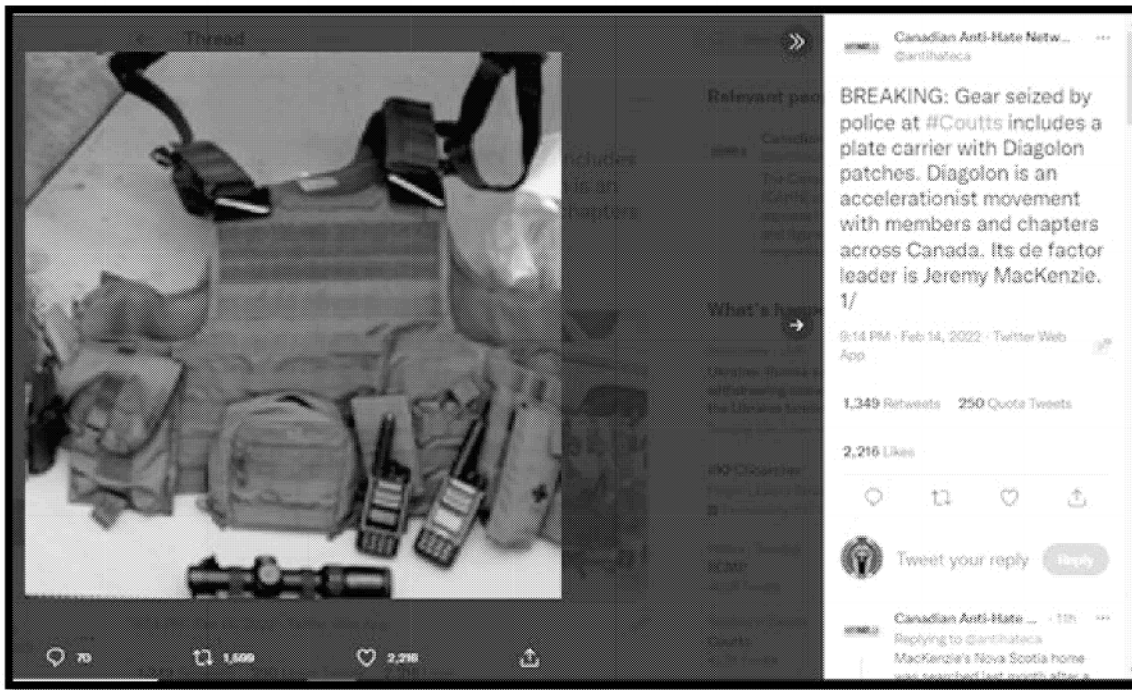

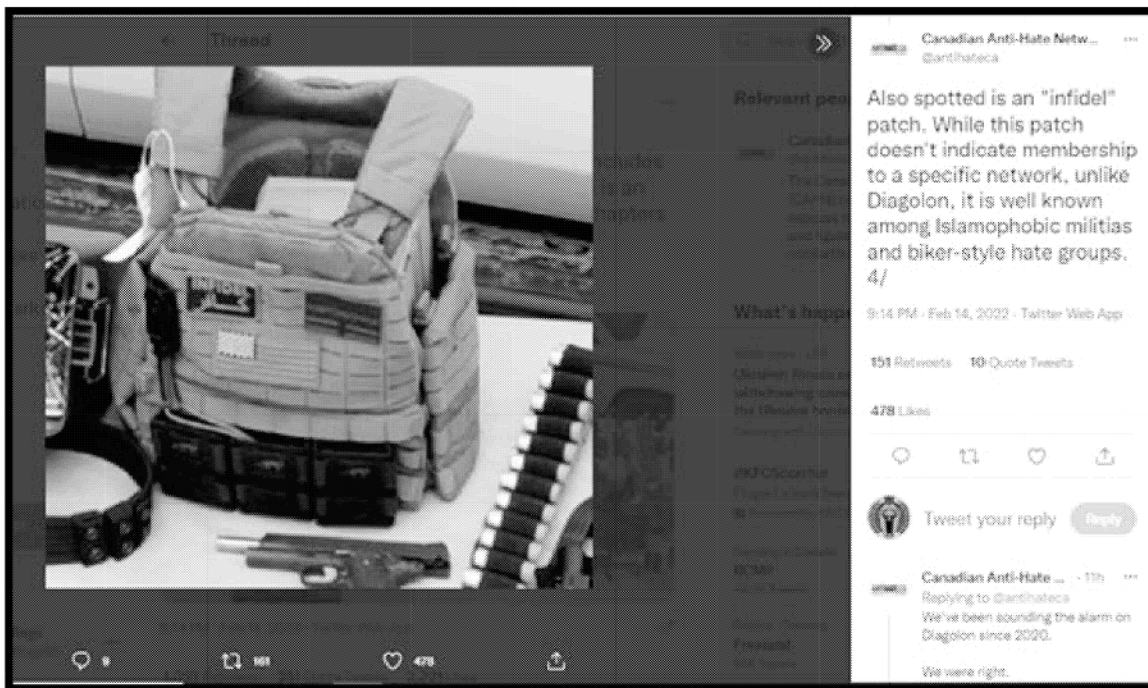

**ADDITIONAL INTEL UPDATES:**

CIG-OSINT located a video published early morning on the 2022-02-15, likely filmed in the evening of 2022-02-14. In the video, Daniel BULFORD makes a statement with the following points:

- He introduces himself as Dany BULFORD, former RCMP Sniper, Supervisor and regularly tasked with the protection of the Prime Minister.
- BULFORD states that on 2022-02-14, they received information from multiple sources, believed reliable.
- Source states that multiple firearms are being planted in Ottawa, specifically around the Freedom Convoy.
- The firearms are planted to discredit the convoy and give pretense to remove peaceful protesters.
- They are revealing this information due to it's nature, in the interest of public safety.

- Claims the intelligence gathered correlates with the 2000 firearms stolen in Peterborough.
- Source claims those firearms will be planted by “nefarious elements”.
- Claims they don’t have anymore information on who is behind this “act of sabotage”.
- BULFORD indicated that as soon they received the information, they alerted OPS, PPS, OPP, RCMP.
- Implores demonstrators that if they see something suspicious to call 911 immediately.
- Many came to demonstrate peacefully and asks the police not to act indiscriminately
- Asks that all scrupulous journalists to turn their investigative talents on this matter.
- They expressly affirm that change can only occur through a democratic process.
- They do not intend to step outside of the democratic process.
- Public and police safety is paramount to them.

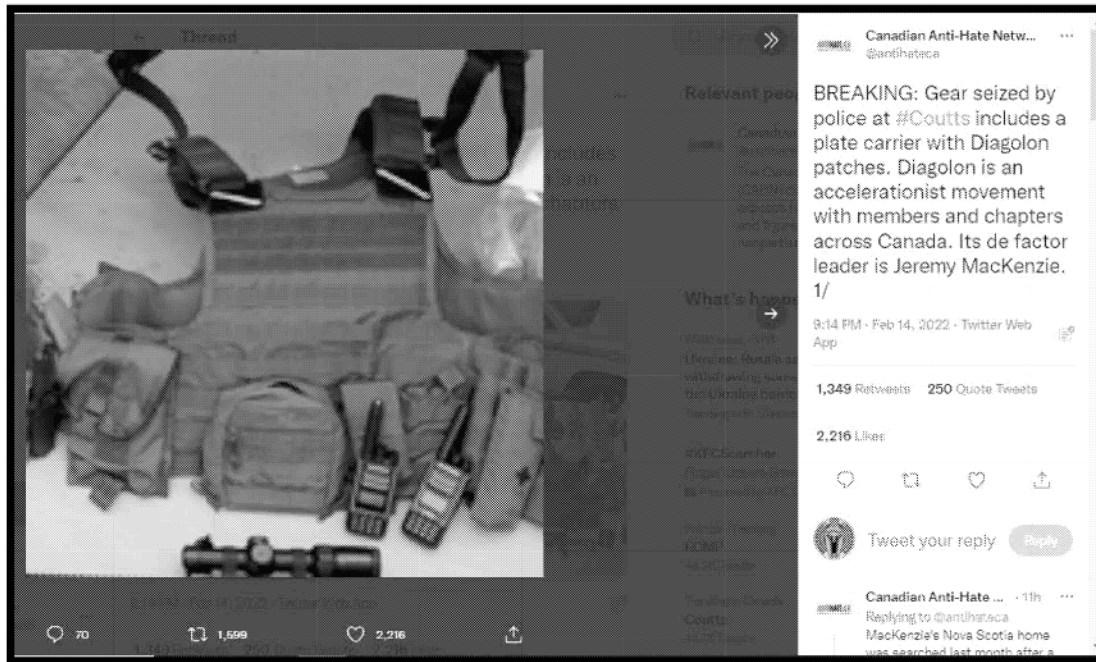

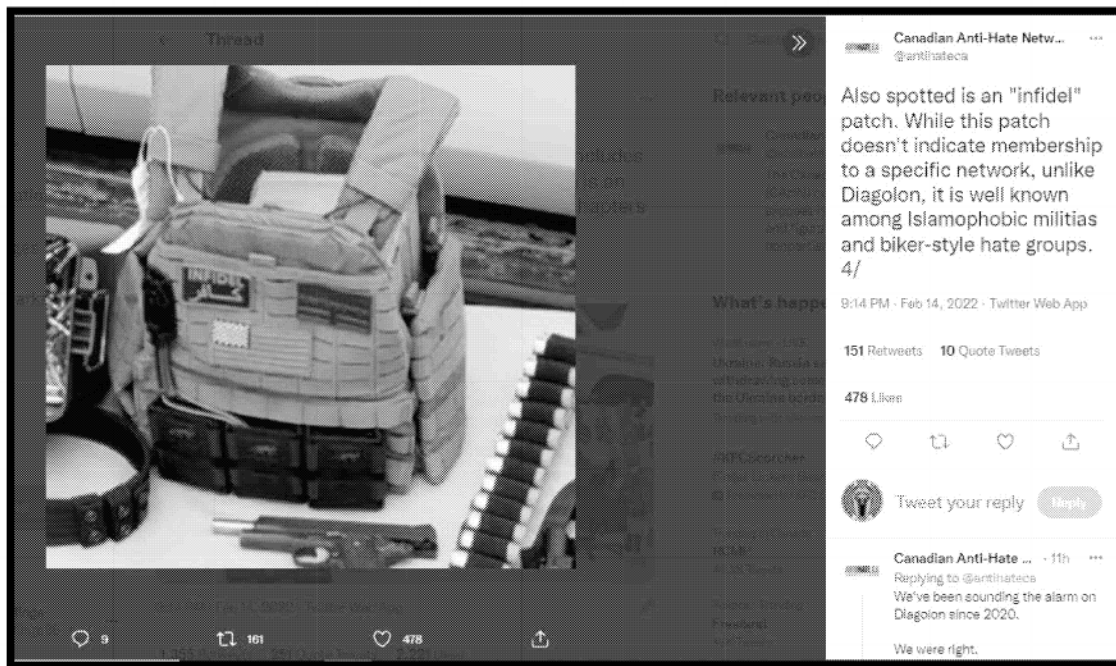

**ADDITIONAL INTEL UPDATES:**

CIG-OSINT located a video published early morning on the 2022-02-15, likely filmed in the evening of 2022-02-14. In the video, Daniel BULFORD makes a statement with the following points:

- He introduces himself as Dany BULFORD, former RCMP Sniper, Supervisor and regularly tasked with the protection of the Prime Minister.
- BULFORD states that on 2022-02-14, they received information from multiple sources, believed reliable.
- Source states that multiple firearms are being planted in Ottawa, specifically around the Freedom Convoy.
- The firearms are planted to discredit the convoy and give pretense to remove peaceful protesters.
- They are revealing this information due to it's nature, in the interest of public safety.
- Claims the intelligence gathered correlates with the 2000 firearms stolen in Peterborough.
- Source claims those firearms will be planted by "nefarious elements".
- Claims they don't have anymore information on who is behind this "act of sabotage".
- BULFORD indicated that as soon they received the information, they alerted OPS, PPS, OPP, RCMP.
- Implores demonstrators that if they see something suspicious to call 911 immediately.
- Many came to demonstrate peacefully and asks the police not to act indiscriminately
- Asks that all scrupulous journalists to turn their investigative talents on this matter.
- They expressly affirm that change can only occur through a democratic process.
- They do not intend to step outside of the democratic process.
- Public and police safety is paramount to them.

- PPS-PI located a video posted to Rumble by Jeremy MACKENZIE on 2022-02-15. In the video of approx. 3 hours, MACKENZIE discussed various topics, however a few quotes of concern from the video have been flagged below by the CIG:
  - 29:27 - "I don't know what can be done for me... the only request I have \*5 sec pause\* the only thing I can ask is... that ummm...just, just take care of my friends and my family if something happens"
  - 30:24 - "if anything happens to me, I didn't kill myself, I'm not suicidal, I have every intention to be alive."
  - 34:33 - "I'll be on the move shortly, don't know where, don't ask me where I'm going, because I don't know yet... \*whispers\* I don't think it's going to pan out here"
  - 48:14 - "There's some shitty people in this world and they're going to get what they deserve."
  - 58:20 - "I'm thousands of dollars in this. I've made two trips already (from NS to Ottawa)."
  - 59:38 - (referencing southern Alberta seizure of weapons) "I don't know who they are - but there \*pointing at diagonal flag\* has been some community associated paraphernalia confiscated, by the police... is that real? Did they put it there?.. They lie all the time, the RCMP does what's good for the RCMP."
  - 1:08:17 - "shout out to Canada First, ... all the PPC boys..."
  - 1:28:57 - "Your (police) job is just going to get harder and harder".
