### CIG #153 DIAGOLON patches found at Coutts seizure

CIG OSINT reports that the Canadian Anti-Hate Network posted images on their Twitter page (@antihateca) of the gear seized at the Coutts blockade. The gear seized includes a plate carrier with DIAGOLON patches. The de facto leader of DIAGOLON is reported to be Jeremy MACKENZIE aka RagingDissident who has been in Ottawa to attend the protests. Open source reports state that several member of the so-called Plaid Army, a neo-fascist group that wishes to stage a violent revolution to establish a new "Diaoglon" – a countray joining the Canadian West with parts of the United States – have been spotted in downtown Ottawa during the protests, although this has not been confirmed.

An "Infidel" patch was also spotted amongst the seized gear at Coutts. According to the Canadian Anti-Hate Network, the "Infidel" patch is know among Islamophobic militias and biker-style hate groups.

K-Division GIS have made a major operation to gather evidence and Intel in regards of who was the leader and conspiracy in the Coutts POE blockade. discovered a large plot and the conspirationist had at access to large cache of firearms in the Coutts protest group. Search warrants have been granted and arrest have been made. Numerous firearms have been seized as well as bullet proof vests and one of them had DIAGOLON patch on it and is believed to belong to along with other individuals (total of 13 for different reasons) in the plot have been charged with conspiracy to commit murder, possession of weapon, mischief and uttering threat. K-INSET is assisting to cover the possible NS Nexus. FPNS is assisting as needed.

2022-196405 : provided the information has an illegal firearm. is pictured on Facebook holding an assault weapon. is a part of the Freedom Convoy. After checks the name is confirmed and of one of the Freedom Convoy protest in Ottawa had

FPNS is following up on bail call and the file will need to be given to a INSET unit (K Edmonton or Ottawa) to investigate possible Art. 59 and under 83 if he meets the definition.

2022-197226 : FPNS received a complaint about COM claimed he is in Ottawa at the protest/blockade and is possibly armed, as he told to FB friends/acquaintances that he was here for the last stand. COM believe that is armed and as an serious in his statement. COM was contacted to try to corroborate the statement and he is the third party and was not the witness of the FB discussion. COM was contacted again later on 3 occasions to provide with printscreen of the threat and to ask his friend who as direct witness to contact the RCMP to provide details. SOC was located few days later back home in and told to the RCMP that he was at the Ottawa protest and now was back home and may be he will return to Ottawa later. denied had put on FB anything that could be perceived as a threat. He was very frustrated about the government position on the protest COM didn't called back after three messages, and seems upset about the restrictions, but didn't stay in Ottawa too long.

1:21:29 - MACKENZIE makes reference to the Peterborough truck heist calling out police for not focusing on that, but focusing on him. Implying that police are listening in on his every conversation.

1:27:06 - MACKENZIE shows footage of clearing Ambassador Bridge. Mistakenly identifies the location as Ottawa. He also mistakenly refers to OPP as RCMP.

1:28:57 - "Your (police) job is just going to get harder and harder".

1:32:44 - "People need their ass kicked from time to time."

1:33:34 - "I'm not just one guy. I used to be, but I guess i'm not now."

1:41:18 - "I can't count on one hand the amount of problems I have."

1:47:11 - MACKENZIE describes the Diagolon flag as "Our community flag", "it's branding", "a meme", he goes on to ridicule the idea that people think this is an honest to God attempt to create a country. Saying he was "literally high on edibles when I came up with this and said, I can't wait until this flag is a hate symbol."

1:43:52 - "You think KEKistan is funny, I fucking doubled down on KEKistan, this is literally a black flag with a line through it I fucking painted with my finger on a phone."

1:49:40 - MACKENZIE does another Diagolon Salute.

1:51:03 - MACKENZIE references a phone call he had, that others of his community were present and heard it on speakerphone, claiming someone he once served with and is a serving NCO told them the truth and fired them up.

1:56:13 - (Referencing the War Memorial event) He spoke of his friend and the "saying "they are willing to go all the way".

2:02:43 - "I'm kinda a psycho".

2:09:51 - MACKENZIE discusses taking money out of the banks so as not to have assets frozen.

2:10:31 - MACKENZIE references how there are 3000 people watching his video, insinuating that there are "paid people" watching.

2:11:20 - MACKENZIE again refers to Diagolon flag as a meme.

2:12:02 - MACKENZIE states that he knows nothing about the Alberta seizure. "They need a bad guy".

2:12:43 - MACKENZIE references his friends stabbing him in the back.

2:30:33 - MACKENZIE calls out Andrew DOUGLAS of Frank Magazine accusing him of having doxxed his whole family.

2:45:07 - Alex VRIEND is mentioned by MACKENZIE as having sent the link to the Danny BULFORD video posted online on 2022-2-14 in which BULFORD makes a claim that the RCMP is planting guns downtown to legitimize arrests.

2:46:11 - MACKENZIE states that he has "a couple ideas Danny" of who planted the guns.

2:47:49 - MACKENZIE refers to a video he has of footprints around where he is staying and that if need be he will release it. He goes on to state he believes his phone is tapped, that there are secret operations taking place against him.

2:49:37 - MACKENZIE states he may "bounce" write after the live stream is done.

2:49:48 - "They could have planted weapons all over the place".

2:49:59 - "If something happens to me, there is this for posterity. There are 3000 people who have seen this."

2:50:20 - MACKENZIE describes what he believes was an encounter with an undercover police officers "dressed as a farmer".

2:54:00 - MACKENZIE describes Canada as a "rogue province" in a "world country".

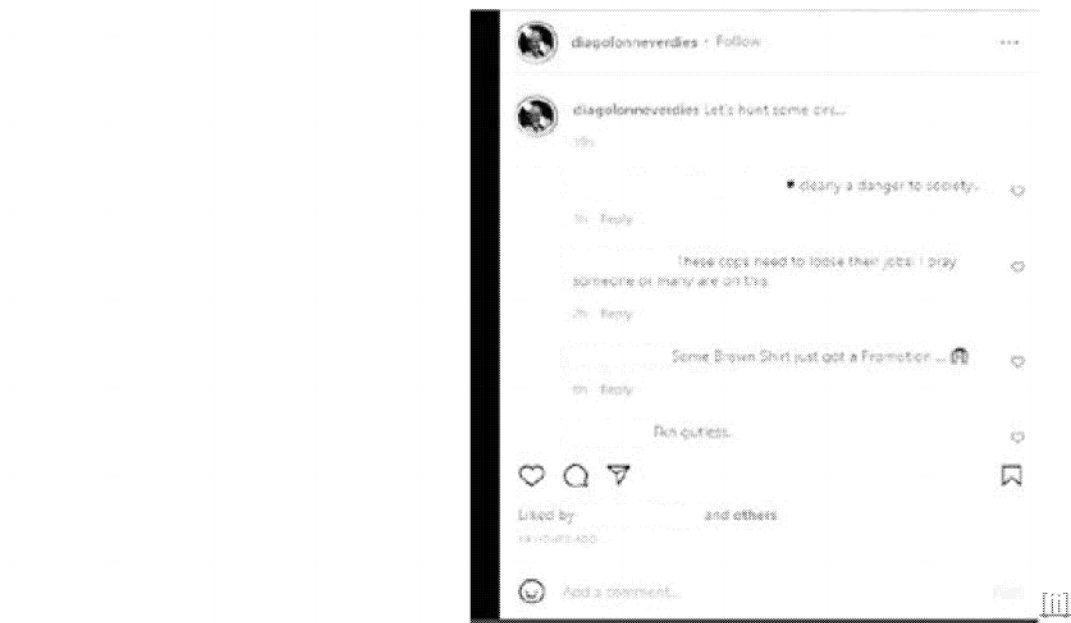

- An Instagram user, @diagolonneverdies, has made a series of posts calling for violence against law enforcement and the general public on 2022-02-07.
  - On 2022-02-07, @diagolonneverdies posted “Let’s hunt some circ...” alongside a picture of a FREEDOM CONVOY 2022 protester being arrested by law enforcement. “Circ” likely refers “Circulon,” a word used by followers of the PLAID ARMY/DIAGOLON to denote those that do not support their political beliefs.<sup>[1]</sup>



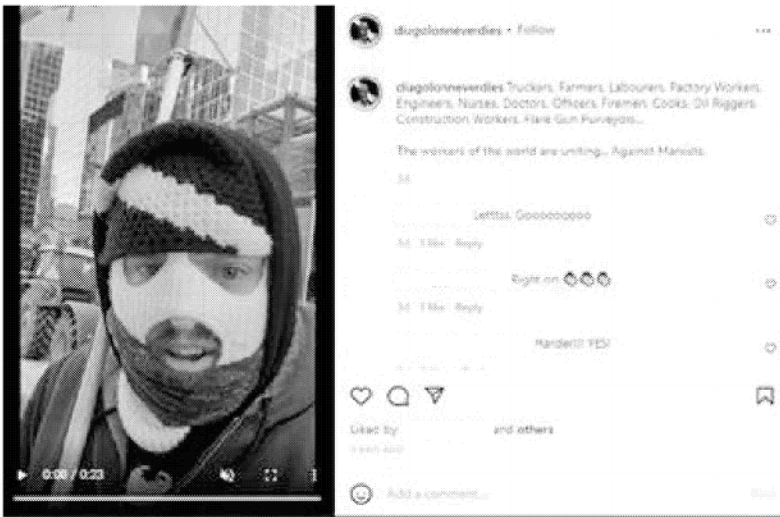
- On 2022-02-07, prior to the above post, @diagolonneverdies made another post stating, “One idiot cop like this is going to make this problem a whole lot worse if they keep this crap up.”<sup>[iii]</sup> This post also appears to have been made in reference to the arrest of a protestor.
- A statement from @diagolonneverdies on 2022-02-06 (post mentions two days ago) references an individual named \_\_\_\_\_ stating, “  
... Let’s do it, sanctioned, in a ring.”<sup>[iv]</sup>
- @diagolonneverdies is likely the same user behind the Instagram account @ferrymans\_toll, who was previously identified by CIG OSINT walking with Jeremy MACKENZIE looking to \_\_\_\_\_<sup>[v]</sup> Images from the accounts of @diagolonneverdies and @ferrymans\_toll both depict an individual donning an identical black hat with the Diagon stripe, along with a white facemask.

- The moniker “The Ferryman’s Toll”, which is similar to @ferrymans\_toll, has been linked in open sources to “Alex Vriend”.<sup>[vii]</sup> Vriend is allegedly a member of the DIAGOLON and its related PLAID ARMY movement.<sup>[viii]</sup> VRIEND is also known to be an associate of Jeremy MACKENZIE.<sup>[ix]</sup> The website, anti-hate(.)ca, claims that Vriend has previously urged violence at protest events.<sup>[x]</sup>

- OPS and CBSA assisted in identifying the individual as Alexander ' VRIEND ( ). CIG has provided OPS with the information for further action if required.
- PPS identified on an open source Instagram account belonging to a supporter of Diagolon (possibly Alex VRIEND) posting possible leaked information from the City of Ottawa detailing chartered buses transporting support police staff from other jurisdiction.<sup>[xii]</sup>



**POSSIBLE UPCOMING CONVOY:**

- As per CIG Update #105, CIG OSINT located a Twitter post by MPP Randy HILLIER, posted at 1915hrs on 2022-02-07, where HILLIER appears to be promoting and possibly organizing a convoy of trades and construction workers. HILLIER indicates that details are pending.

**ADDITIONAL INTEL UPDATES:**

- HILLIER interview with Russian state-owned media:
  - Randy HILLIER appears to have uploaded an interview with RT, a Russian state-owned media on 2022-02-07, on the website odysee(.)com. The video was possibly uploaded on 2022-02-07.
  - In the interview, HILLIER speaks against COVID-19 measures and derides the Government of Canada and Prime Minister Trudeau for spreading “propaganda” as a means of destroying constitutional rights. HILLIER also speaks out against the GoC for what he perceives are attempts to discredit the Freedom Convoy 2022.
  - RT has been commonly identified as a Russian state-funded and state-directed media source. (e.g. <https://www.state.gov/report-rt-and-sputniks-role-in-russias-disinformation-and-propaganda-ecosystem/>)
  - The full video has been captured by CIG Open Source.
- On 2022-02-08, OPS received information that [redacted] sent an email stating that the user, possibly [redacted] is in the process, along with Randy Hillier, of organizing a convoy of trades’ people to drive to the Hill from three staging areas this Sunday.
- Citizens advised RCMP members located at Portage Bridge in Gatineau that some of the protesters were hiding gas cans “inside” a snow bank at Portage Bridge.

### **SOI/PPPOI:**

- CIG OSINT identified a tweet commenting on a video of George Billings. In the video, what appears to be the voice of Pat KING can be overheard talking about the honking and to "piss them off" by moving the vehicles but staying close to residential areas. [iii]
- CIG OSINT identified a live stream on 'The Real Pat King' Facebook page posted and entitled 'ENROUTE'.
  - KING appears as a passenger in a pick-up truck which is driving around downtown Ottawa and says they are heading to Wellington Street (driver shouts 'Freedom' in male voice, possibly BILLINGS). KING states he has seen the paper being circulated but since there is no signature or stamp people can't be scared. He says "do not bend the knee" and that they will have to start doing night shifts to be vigilant and stand their ground. The vehicle parks in front an 'EQ3' sign which is a furniture store at 60 Byward Market Square and KING continues to walk on foot to Rideau and Sussex. He calls for fuel to be transported Rideau and Wellington.



### **PROTECTIVE INTEL:**

- CIG was notified by the RCMP Protective Operation Coordination Centre (POCC) of an indirect threat towards DPM FREELAND. An email was sent to DMP FREELAND's office stating the following: "I declare war on all the CANADIAN government for lying about covid-19. Chrystia Freeland will get a bullet to the head. Prepare to feel (our) WRATH!"

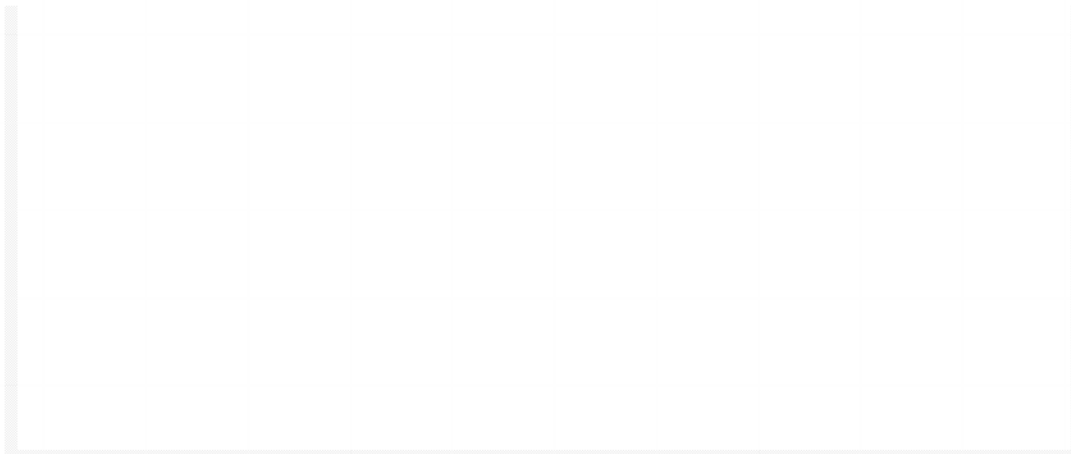

- CIG OSINT located a post about the arrests in Coutts, AB. The post was on a Diagon page and states, “some brothers from our communities were taken into custody and have a huge battle in front of them”. The message goes on to ask for funding to pay for legal fees. There is an e-mail included at the bottom of the post.
  - Jeremy MACKENZIE has been claiming that the patches on the body armour are not a product they have sold and that it is “off- brand”. MACKENZIE has been distancing himself from any Diagon involvement in the Coutts arrests.



- Individuals that identify themselves as police officer continue to show support to the protests. CIG OSINT located a YouTube video posted today by user [redacted] which shows a female in a black police vest with the nametag [redacted]. User states "I support freedom and I support a return to normal". The video currently has 23,268 views.



- **CBSA reports the following updates:**

- **Grentna (MB)**

- An increase in wait times from an hour and 45 minutes to two and a half hours has been reported due to the increase in commercial traffic partially attributed to the Emerson closure.

- **Emerson (MB)**

- Emerson POE is open and has now resumed normal operations.

- **Osoyoos (BC)**

- Two vehicles consistent in appearance to those observed at previous protests north of the POE have shown up. One of the vehicles is recognized as a vehicle that has always shown up prior to the larger protest group arriving.

**NUMBERS:**

- Less than 10 demonstrators reported on PH
- Approx. 100 demonstrators reported on Wellington.

  - 29:27 - "I don't know what can be done for me... the only request I have \*5 sec pause\* the only thing I can ask is... that ummm...just, just take care of my friends and my family if something happens"
  - 30:24 - "if anything happens to me, I didn't kill myself, I'm not suicidal, I have every intention to be alive."
  - 34:33 - "I'll be on the move shortly, don't know where, don't ask me where I'm going, because I don't know yet... \*whispers\* I don't think it's going to pan out here"
  - 48:14 - "There's some shitty people in this world and they're going to get what they deserve."
  - 58:20 - "I'm thousands of dollars in this. I've made two trips already (from NS to Ottawa)."
  - 59:38 - (referencing southern Alberta seizure of weapons) "I don't know who they are - but there \*pointing at diagonal flag\* has been some community associated paraphernalia confiscated, by the police... is that real? Did they put it there?.. They lie all the time, the RCMP does what's good for the RCMP."
  - 1:08:17 - "shout out to Canada First, ... all the PPC boys..."
  - 1:28:57 - "Your (police) job is just going to get harder and harder".
  - 1:47:11 - MACKENZIE describes the Diagonal flag as "Our community flag", "it's branding", "a meme", he goes on to ridicule the idea that people think this is an honest to God attempt to

BARBER explains "...it is a time when we shut our ignitions off, shut our work off, we kill it for the entire 7 days, take some time with your family...what better way to solve a tyrannical government than by taking a week off". also announces a worldwide 'Jericho March' at 1300hrs this Thursday which will feature honking for seven minutes straight.

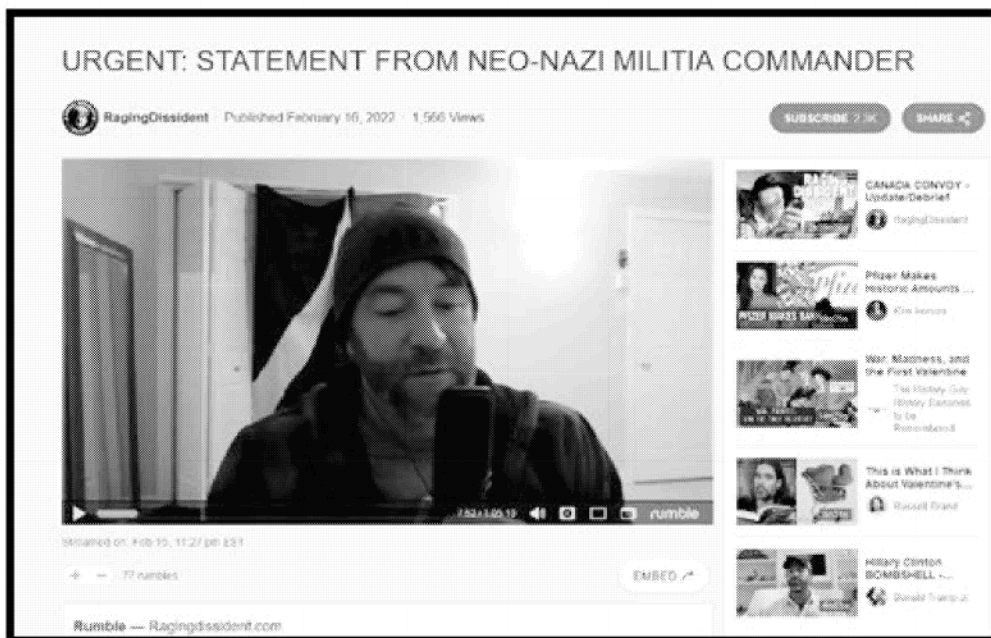
- CIG OSINT has observed a video shared on Twitter which appears to show that [REDACTED] is currently near Parliament Hill.

- PPS-PI located a video posted to Rumble by Jeremy MACKENZIE on 2022-02-15 at approx. 2357hrs. In the video, MACKENZIE discusses various topics, however a few quotes of concern from the video have been flagged below by the CIG:
  - 00:09:24 - "As you may or may not be aware, there was a bunch of arrests made in Coutts Alberta, those guys have packed up and going home, I guess."
  - 00:09:43 - "I posted a photo of the loot-haul that was allegedly seized by the RCMP there... **they made a note to point out that one of our symbols here \*points at Diagonal flag behind**

him\* this flag which I'll explain in a minute, was seen on some of the equipment there. I have no idea where those came from, who those belong to, who put them there, who brought them there, did the police put them there? As far as the situation goes in Alberta, I have no idea what went on there."

- 00:15:11 - "As far as this flag goes, its literally a joke that I made... first of all if the name isn't readily apparent, its name... Diagonal... I was pretty stoned on edible marijuana when I came up with this."
- 00:16:12 - MACKENZIE describes how he had noticed that all the US militias that have agreeable politics to his own seemed to form a diagonal line from Florida to Alaska. So I called it Diagonal and its a pretend country that doesn't exist."
- 00:24:39 - "I'm going to be emptying my entire cryptocurrency wallet - for cash - if you guys wanna go for war, I guess that's what you want."

- CIG OSINT located a video posted to the Facebook page "The Real Pat King" on 2022-02-15. In the video, Pat KING discusses various topics, however a few statements of concern from the video have been flagged below by the CIG:
  - Speaking about the trolls KING states: "They are tearing people apart. They are slandering individuals and local businesses that donated to the occupiers"
  - KING indicates that people can have their voice, but not to attack others, harass and slander people.
  - Kitchen Party on Saturday Wellington Street.
  - KING states he would love to go to Cape Breton, see his friend,

- He was asked to cover the story of the 40 000 vessels that are going to surround Nova Scotia and New Brunswick.
- Demonstrators are being “hand fed” money at strategic times so they are well taken care of.

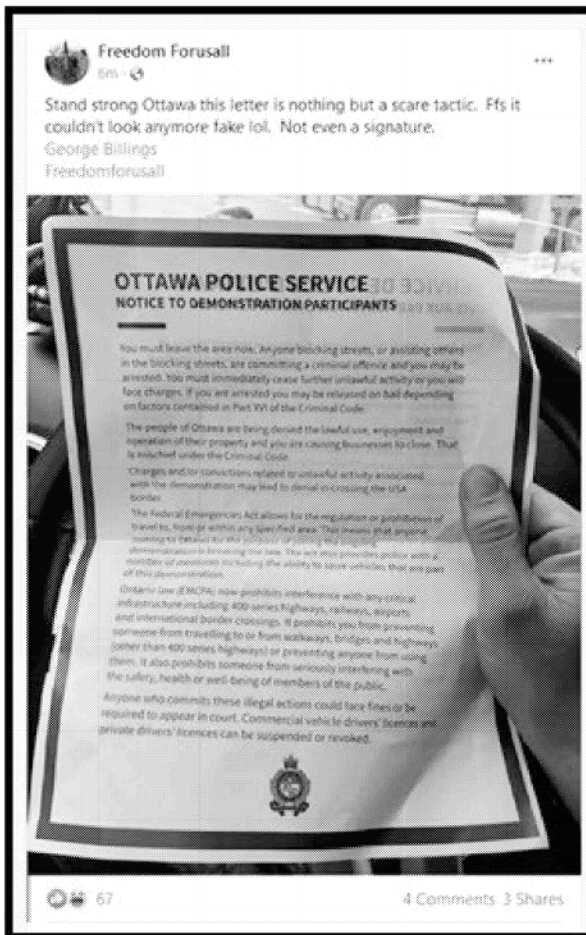
- CIG OSINT identified a tweet on the account associated to [redacted] at 0926hrs: Has Canada entered a phase of financial tyranny? The post shares an article by The Counter Signal which claims they exclusively obtained an order sent by the RCMP which demands that all FINTRAC regulated companies in Canada cease transacting with 34 cryptocurrency wallets alleged to be associated with the Freedom Convoy in Ottawa. This includes a wallet associated with the HonkHonkHodl campaign which contained over \$1 million.

- CBSA reports the following updates:
  - Patterson, BC
    - 8 Vehicles and approximately 8-9 people remain on site. One lane is open and traffic is still able to move in both directions. Vehicles have been moved to one side of the highway to create additional room for vehicles to pass. Protest participants remained quiet and peaceful throughout the day and night.
    - Intel Update: A new poster is circulating for the event on Saturday and they are now calling for an event on Sunday as well. Those camping there seem quite set to stay, and others possibly joining for the long weekend.
  - PAC highway, BC
    - There are no current protests at the Pac Hwy POE
    - There are no USA based protests
    - RCMP have checkpoint's set up south of the Visitor Centre on 176th Street and at 184th Street and 0 Ave.
    - There are currently no blockades being reported by the RCMP nor visible on our cameras
