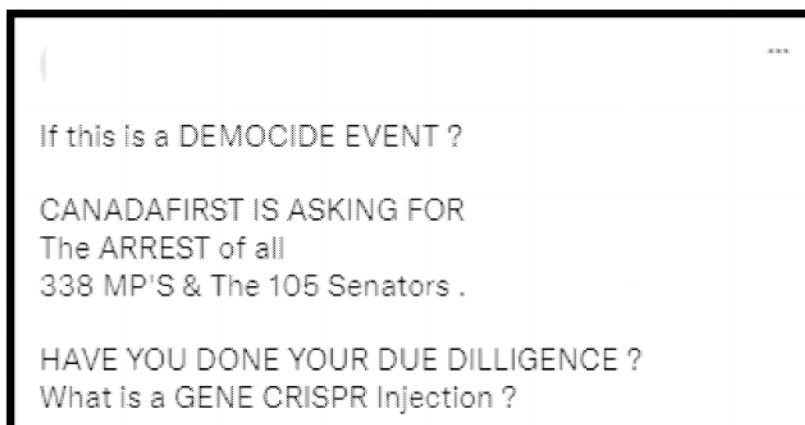
- OPS advised of Arrest warrant for Matthew DORKEN. DORKEN is wanted on Reasonable probable grounds after committing mischief at 255 Albert St. Ottawa. If arrested, DORKEN can be released on an Adult Undertaking with the condition, not to attend 255 Albert St, Ottawa.

SOI/PPPOI:

- CIG was advised that OPS has arrested Jeffrey GALLANT at approx. 1200hrs.
- OPS advised that they received a call from an individual who saw a post from (on Facebook) who reportedly said that he was ``making home made fireworks like bombs in his home and was going to head downtown to kill cops if they were going to (fuck) with him``. No additional details provided. CIG OSINT analyst could not confirm this information. Facebook post could not be located. OPS currently looking into this.

INTEL UPDATES:

- A tweet alleges that the Canada First group is asking for the arrest of all Members of Parliament and Senators. Original Canada First post could not be identified. CIG will continue to monitor for any threats towards MPs.

- Information received from CS-SAA-RMI: In the [redacted] channel, protesters are moving out of the Coventry locations to leave their trucks overnight. They are headed to Exit 88 near Embrun. They have a shuttle bus to bring people from Exit 88 to downtown Ottawa. 302 Coventry Rd has become a coordination centre.
- CIG was advised of two (2) vehicles in Chelsea. Vehicles could be scouting the area.
 - SUV – Ontario marker [redacted] – Had flags on it, but since removed after parking in Chelsea. “I want to be free” written on the side panels.
 - Pickup truck – Saskatchewan marker [redacted] – was decked out with flags and decals. Last seen a few minutes ago taking the highway 5 South from Old Chelsea Road.
- CIG observed images of an individual carrying a Diagonal flag at approx. 1445hrs on live feed of cameras.

In the same video, “Alex” is shown wearing a white balaclava and a knitted toque with the Diagonol flag pattern.
 - CIG OSINT identified “Alex” as going by the Instagram username @Ferrymans_tolls. “Alex” is pictured with MACKENZE.

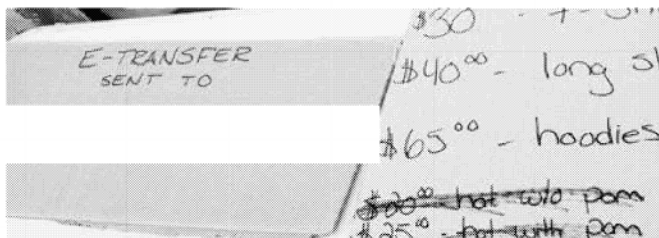

- CIG was advised that there is significant foot traffic on Wellington.
- CIG received information that a speaker on stage is asking people to bring fuel.
- Ottawa Major Jim WATSON declared a state of emergency for the city of Ottawa as the "Freedom Convoy" demonstration continues to occupy the downtown area.⁴

DEMONSTRATIONS IN OTHER CANADIAN CITIES:

- CBSA advise the blockade in Sarnia is dispersing. Tractors are now departing via eastbound 402, however OPP advised that several participants expressed intentions to remain to "hold the line". This is a slow process, but all is going well.
- Quebec Police advise, through OPS, there are approximately 200 protesters and 17 trucks on René-Lévesque at the National Assembly in Quebec. Organizers told Quebec Police that they plan to return to demonstrate on 2022-02-18 and 2022-02-19.

NUMBERS:

- Approximately 20 demonstrators reported on Parliament Hill.
- Approximately 75 demonstrators reported on Wellington St.

- NSIN Tip received regarding threats made in far-right online spaces towards the defendant in the class action lawsuit against the Freedom Convoy coordinators and participators. FPNS liaised with OPS who have the lead. There is no offence committed but safety concerns exist. RCMP file concluded.

PROS : 2022-167554

- File generated in regards to multiple threats of violence made about PM Trudeau and the burning down of Parliament over BitChute. POCC tasked out on file for awareness under their protective mandate. TIOS has been tasked to capture all postings and to attempt to identify and geo locate the SOC. Once located/identified FPNS will task the appropriate investigative agency.

PROS 2022-154989:

- Anonymous information on unknown reliability from Reddit advising that [redacted] is providing weapons to the protesters. [redacted] has previous conviction for manufacturing firearms. SOC's last known address is in [redacted] RCMP Detachment tasked to attempt locating [redacted] for interview. A PIU Officer Safety bulletin has been distributed regarding [redacted] Investigation is ongoing.

CIG update #111 Review results:

OA presented this report for FPNS review. In summary, no criminality was detected however lead was passed to POJ for review:

- PPS identified post from Instagram account @diagolonneverdies possibly leaking information from the City of Ottawa detailing OC transpo chartered buses transporting supporting police personnel from other jurisdiction.
- CIG further reports that @diagolonneverdies posted "Let's hunt some circ..." alongside a picture of a FREEDOM CONVOY 2022 protester under arrest by law enforcement. Circ" likely refers to "Circulon," a word used by followers of the PLAID ARMY/DIAGOLON to denote those that do not support their political beliefs.
- OPS and CBSA have possibly identified the individual associated to @diagolonneverdies as Alexander VRIEND (DOB [REDACTED]).
- FPNS has confirmed that OPS is aware of the leaked OC Transpo email and its implications for officer safety. OPS has taken steps to ensure that buses carrying police personnel and the routes they travel are secure.
- FPNS has reviewed the posting provided in the CIG report and have found nothing to support a national security criminal investigation. Liaison with OPS via the CIG confirmed OPS is aware of VRIEND.

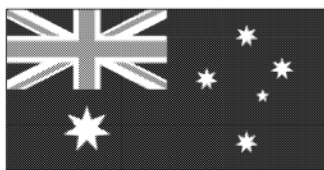
Recent collection of publicly available images (social media / open internet), conducted by RCMP J Division Criminal Analysis Section, of demonstration activity in Fredericton, NB (2022-02-11/13) has identified the presence of symbology (flags, signs, banners, etc.) linked to ideologically-motivated violent extremist (IMVE) groups or movements.

While the vast majority of demonstrators have publicly denounced the use of violence, the presence of IMVE symbology suggests there are participants that may subscribe to ideology previously linked to violent encounters with law enforcement. The seizure of weapons and body armour at the Coutts, AB demonstration is indicative of the degree of violence some demonstrators are willing to undertake.

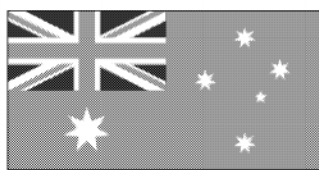
Please keep the following symbols in mind, particularly when conducting traffic stops. Many demonstrators have continued to fly flags and banners days after the Freedom Rally or Freedom Convoy events concluded. Please notify RCMP L Division Criminal Analysis Section of any encounters with individuals or observations of vehicles displaying this symbology.

National Flag of Australia / Australian Red Ensign Flag / Australia’s Eureka Flag

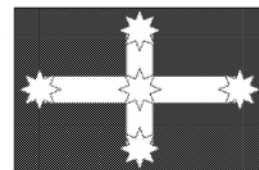
The presence of the National Flag of Australian (bottom left) at demonstrations is in protest to the public health measures taken by the Government of Australia, which have been perceived as harsh and repressive against Australian citizens. The Australian Red Ensign (bottom center), a predominantly red version of the Australian national flag, has been adopted by the country’s Sovereign Citizen movement. The Eureka flag (bottom right) has roots in Australia’s multiracial miner’s protest in the early 20th Century and indicates nationalism and radicalism. It has since become a white supremacist symbol. Several Australian national flags (blue version) were observed at the Fredericton Freedom Rally on 2022-02-11/13.

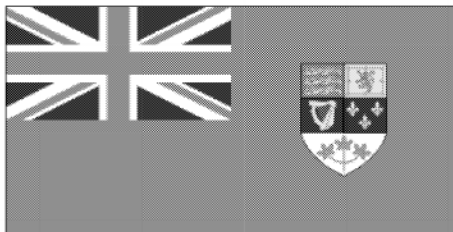

Canadian Red Ensign Flag

The Red Ensign (below) was Canada's national flag between 1892 and 1965, when it was replaced by the Maple Leaf used today. Note that it is similar to the Ontario and Manitoba provincial flags – the shield on the right differs from the provincial flags.

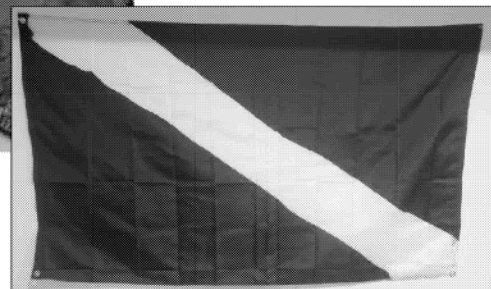
The flag has been adopted by white ethno-nationalists, referencing a time when they believe Canada was predominately white. The image at right was taken at the demonstration in Fredericton.

Diagolon Flag (The Plaid Army)

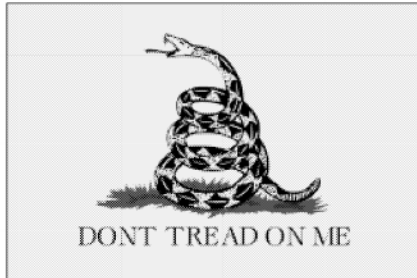
The Diagolon flag, a diagonal white stripe on a black background, is the symbol of The Plaid Army, a group of neo-fascist accelerationists who promote a violent revolution to establish a new country made up of elements of the mid-western US states and western Canadian provinces. The image below (left) was taken at the protest in Fredericton. Diagolon supporters have been observed at the Freedom Convoy protest in Ottawa, and Diagolon supporter badges were found affixed to body armour seized at the Coutts, AB demonstration (below centre).

Gadsden Flag ("Don't Tread on Me")

The Gadsden flag has American Revolution roots, and is often used in the United States as a symbol for far-right ideology, limited government / anti-governmental sentiments. The flag is typically yellow with a coiled rattlesnake ready to strike (below left). In the Canadian context, the snake has been replaced by a beaver or a Canada Goose (below right), which in this case, can be purchased from Amazon Canada. The image below (centre) was taken in Fredericton, NB.

FARFADAA / Patroite Flag

A splinter group from La Meute (a Québec-based anti-immigration group), FARFADAA promotes Covid-19 conspiracy theories and opposes public health measures. The group uses a middle finger, "F*ck You" symbol. FARFADAA supporters have also been observed with the Patroite Flag, which was used by a Francophone political movement in the mid-1800s. It was revived by the Québec nationalist movement in the 1960s and has been adopted by the present-day Storm Alliance, a Québec-based anti-immigration, ultranationalist group. Two Storm Alliance members were arrested after plotting to assassinate Prime Minister Trudeau in 2019 (Facebook posts). Demonstrators in Fredericton were observed with FARFADAA-inspired signage (below right).

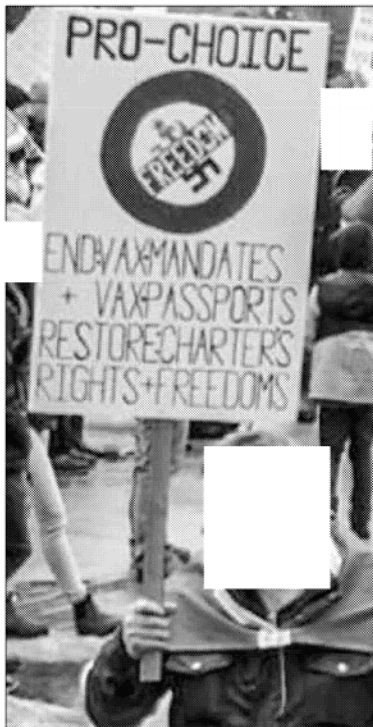

Nazi Symbolology

The presence of Nazi symbols at anti-mandate/anti-government demonstrations is meant to link the current public-health measures to the persecution of Jews and the Holocaust. Variations of the Swastika, the Star of David, and the stylized lightning bolts of the Schutzstaffel (Nazi SS) further represent the imposition of a police state. These images are shared in the white supremacists community. The image below (left) was taken at the demonstration in Fredericton. The images (below centre and below right) were taken at the Freedom Convoy demonstration in Ottawa.

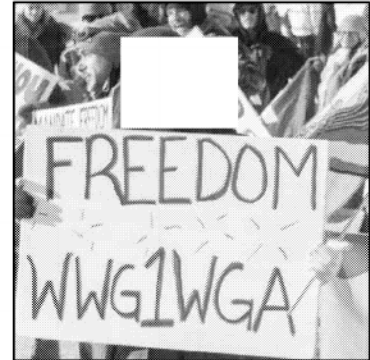

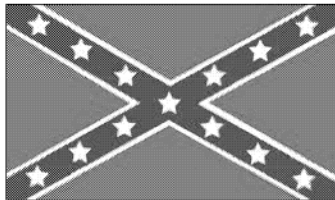
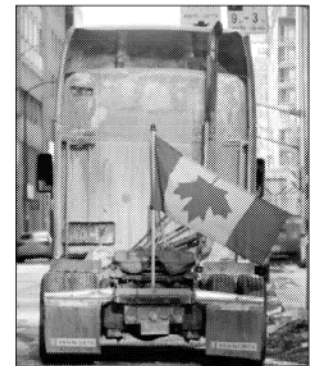
WWG1WGA (Where We Go One, We Go All – Q Anon)

A conspiracy theory movement generated out of the United States, Q Anon followers use WWG1WGA symbology. Q Anon followers believe, among other things, that former US President Donald Trump was waging a battle against a global cabal of Satanic worshipers who were controlling an international child exploitation ring. Q Anon symbology was popular among those involved in the January 6, 2021 insurrection/riots in Washington DC. The demonstrator below was observed in Fredericton, and unconfirmed reports were received that Q Anon symbology was present during the PEI Freedom Convoy on 2022-02-06.



Other Symbology

The symbology presented in this bulletin is only a snap-shot of current trends present within the anti-mandate / anti-government community. Many demonstrators have displayed the Canadian flag upside down (meant as a signal of distress (image right) and others have flown the Confederate flag below (centre), which has long been associated to white supremists movements.

Situation as of 1314 hrs on 2022-02-16

Event Overview:

- **No demonstrators** reported to be on **Parliament Hill** at this time.
- **Approximately 100-150 demonstrators** reported on Wellington and surrounding area.
- The current count is **between 400 and 450 vehicles** in the downtown core and on Wellington.
- Police resources are currently distributing messaging to the demonstrators in the downtown core advising them to leave the area. The messaging can be viewed on the following sites:

- The trailer with firearms stolen from Peterborough on February 13th has been recovered in the Peel area. Peterborough Police and the manufacturer are conducting an inventory of the contents
- The following are possible convoys or demonstrations:
 - Today (Feb 16) – [redacted] has indicated she intends to visit Parliament Hill at some point today
 - Today (Feb 16) – Convoy coming from Sudbury/Sault Ste. Marie meeting in Arnprior at 16:00, intending to come in to Ottawa. Unknown number of participants at this time
 - Feb 19 – Convoy coming from St. Jerome, QC between 20-50 participants
 - Feb 19 – Convoy coming from Calgary, AB, unknown participants

Operational Information:

- **Officer Awareness:**
 - CIG received reports that an unknown male was observed with a possible knife on his right hip. Photo not clear, but can see part of a knife holster.
 - CIG received report that an unknown male was observed wearing hard gloves. Knuckles are covered of plastic/Kevlar. Appears to be cleaning the street around the barricade.
- CIG OSINT has observed a video shared on Twitter which appears to show that [redacted] is currently near Parliament Hill. [i]
- PPS-PI located a video posted to Rumble by Jeremy MACKENZIE on 2022-02-15 at approx. 2357hrs. In the video, MACKENZIE discusses various topics, however a few quotes of concern from the video have been flagged below by the CIG:
 - 00:09:24 - "As you may or may not be aware, there was a bunch of arrests made in Coutts Alberta, those guys have packed up and going home, I guess."

- 00:09:43 - "I posted a photo of the loot-haul that was allegedly seized by the RCMP there... they made a note to point out that one of our symbols here *points at Diagonal flag behind him* this flag which I'll explain in a minute, was seen on some of the equipment there. I have no idea where those came from, who those belong to, who put them there, who brought them there, did the police put them there? As far as the situation goes in Alberta, I have no idea what went on there."
 - 00:15:11 - "As far as this flag goes, its literally a joke that I made... first of all if the name isn't readily apparent, its name... Diagonal... I was pretty stoned on edible marijuana when I came up with this."
 - 00:16:12 - MACKENZIE describes how he had noticed that all the US militias that have agreeable politics to his own seemed to form a diagonal line from Florida to Alaska. So I called it Diagonal and its a pretend country that doesn't exist."
 - 00:24:39 - "I'm going to be emptying my entire cryptocurrency wallet - for cash - if you guys wanna go for war, I guess that's what you want." [iii]
- CIG OSINT located a video posted to the Facebook page “The Real Pat King” on 2022-02-15. In the video, Pat KING discusses various topics, however a few statements of concern from the video have been flagged below by the CIG:
- Speaking about the trolls KING states: “They are tearing people apart. They are slandering individuals and local businesses that donated to the occupiers”
 - KING indicates that people can have their voice, but not to attack others, harass and slander people.
 - Kitchen Party on Saturday Wellington Street.
 - KING states he would love to go to Cape Breton, see his friend, .
 - He was asked to cover the story of the 40 000 vessels that are going to surround Nova Scotia and New Brunswick.
 - Demonstrators are being “hand fed” money at strategic times so they are well taken care of. [iii]
- CIG OSINT identified a tweet on the account associated to at 0926hrs: Has Canada entered a phase of financial tyranny? The post shares an article by The Counter Signal which claims they exclusively obtained an order sent by the RCMP which demands that all FINTRAC regulated companies in Canada cease transacting with 34 cryptocurrency wallets alleged to be associated with the Freedom Convoy in Ottawa. This includes a wallet associated with the HonkHonkHodl campaign which contained over \$1 million. [iv]

- Additional CIG Intel Updates:
- CIG OSINT identified a growing online narrative that the warning from Ottawa Police Service is simply a scare tactic. For example, a post to the Freedom Forusall FB page with an apparent copy of the notice to demonstrators from the Ottawa Police Service.^[v]

On April 5th, 2022, Insp Rabih Abdallah advised Sergeant Kevin Douglas that H Division NSES was possibly starting a probe into the right wing group known as DIAGOLON. Insp Abdallah asked that Sergeant Douglas speak with H Division in order to ensure they were aware of our intel file into (DIAGOLON/right wing supporter) and to coordinate any joint effort that may be required.

At approximately 3:30 pm Sergeant Kevin Douglas spoke with Sergeant Scott Manning, current i/c for NSES in H Division. Sergeant Douglas made Sergeant Manning aware of this intel file in the event that it had any link to an Intel Probe into the group DIAGOLON. Sergeant Manning suggested that Sergeant Douglas speak with Constable Stephen MacKay at NSES.

On April 6th at approximately 11:00 am Sergeant Douglas called Constable MacKay, but there was no answer. Sergeant Douglas subsequently send the following email:

Hey Steve.

I hope all is well.

I just wanted to send you the file number for our intel file into the a/n subject. We were made aware of this person's link to Diagolon by F Div via that secure video conference that you were a part of last week.

Cpl John McBride is the lead on this intel file and CM Ling is looking into the noted subject from the analyst side. There is nothing added to the file at this point, but please reach out to John or Katherine if have any questions.

FYSA should anything you are looking at link with this guy.

Kevin DOUGLAS

At approximatley 12:00 pm Sergeant Douglas spoke with Cst Steve MacKay on the phone. Cst MacKay advised that he was the lead investigator on an Intel Probe into Diagolon in H Division. Cst MacKay also advised that FPNS was coordinating the national effort on this group and suggested that Sergeant Douglas contact Raj Jande and Francois Cormier to make them aware of this intel file.

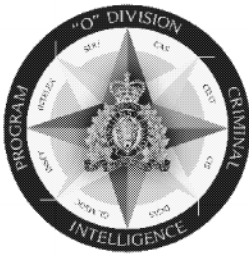

"I declare war on all the CANADIAN government for lying about covid-19.
Chrystia Freeland will get a bullet to the head.
Prepare to feel (our) WRATH!
Yu'res truly,
The CANADIAN covid government resistance.
We will visit you at your home this Friday at 6pm, so you better be hidden and be placed into protection because we know where you live."

AIM

To provide RCMP O Division with passive open source information identified on 2022-02-19 by 2000 hours, pertaining to the ongoing protests known as the "Freedom Convoy" at or near Ontario land and air ports of entry (POE).

KEY FINDINGS

- Traffic was flowing at all POE without delay
- Fewer than 100 protestors attended a rally today in Windsor at the Great Canadian Flag which did not impact operations at the Ambassador Bridge.
- No future protests in Windsor were identified during the reporting period.
- Evidence continues to mount about some of the Windsor protest organizers alignment or sympathy with far right groups.
- Today's Windsor protest organizer posted a video on the group Facebook page of Jeremy MCKENZIE, the leader of Canada's DIAGOLON.

NIAGARA REGION

No protests were observed at the POEs in the Niagara region while conducting searches. No further information was found on the planned slow roll that gathered at 1230 hours at the HUSKY TRUCK STOP at 615 York Road, Niagara. At this time, the QEW remains open.

Peace Bridge

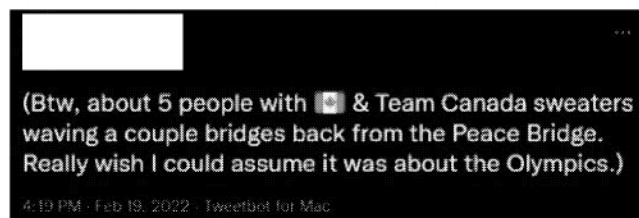


Figure 1 @ *tweet regarding Peace Bridge*

A citizen reported on Twitter that people with Canada Flags and Team Canada sweaters were waving from a couple of bridges away from the Peace Bridge (Figure 1).ⁱ

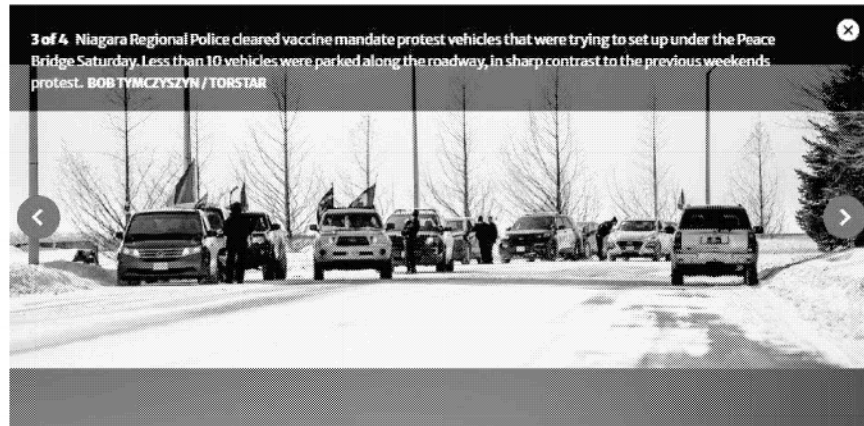


Figure 2 Convoy prevented by OPP from heading toward Fort Erie

OPP followed a small convoy that was headed to Fort Erie (unknown if it is the same group that gathered at the Husky Truck Stop) and were blocked by the Niagara Regional Police from setting up (Figure 2).ⁱⁱ

WINDSOR

Fewer than 100 protestors attended a rally today in Windsor at the Great Canadian Flag (Figure 3, next page). The protest, which lasted less than two hours, did not impact operations at the Ambassador Bridge. No future protests were identified during the reporting period. Several individuals were observed on a livestream commenting that there would be more protests when the weather gets warmer.ⁱⁱⁱ Two of the main Facebook groups used by protestors to organize have changed the account settings private, and are no longer available for passive observation.

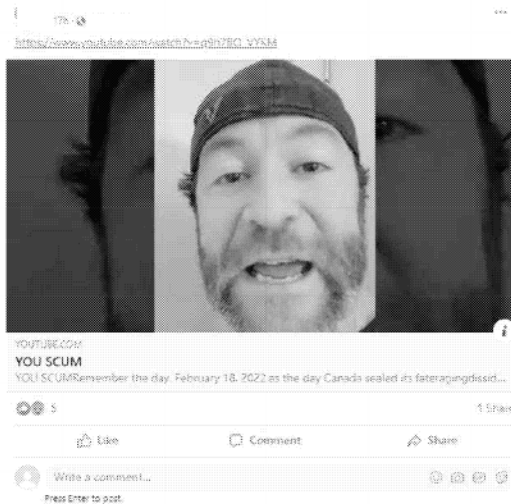


Figure 4: Post from Facebook user ' [redacted] ' ^{vii}

Evidence continues to mount about some of the Windsor protest organizers alignment or sympathy with far right groups. Facebook user " [redacted] ", the organizer of today's protest, posted a video of Jeremy MCKENZIE,^v the leader of Canada's DIAGOLON, a far-right "accelerationist" group (Figure 4). A DIAGOLON patch was found this week on a piece of body armour located in a cache of weapons in Coutts, Alberta. Four men associated to the weapons were charged with plotting to kill RCMP officers.^{vi}

TORONTO PEARSON INTERNATIONAL AIRPORT – YYZ

Uncorroborated information received that a flash demonstration was going to be held at the Toronto Pearson International Airport today (TPIA). Open source searches were not able to confirm this information and no protest reported at TPIA today. Passive searches are continuing in an effort to identify any activity at the TPIA.

STRATEGIC CONSIDERATIONS

As significant law enforcement actions persist in Ottawa, live query support is continuing for posted activities that might change their location from Ottawa to the POEs. With the fluidity and ever evolving situations at or near the POEs, continued live query support of open source media is warranted in order to provide updated situational awareness for RCMP O Division and partner agencies.

LIIMITATIONS

Although every effort has been made to review all publicly visible social media and web sources for information relevant to this brief, the absence of threat information herein should not be taken as an exhaustive examination of potential threats. A large volume of information is available online and constantly evolving.

INTELLIGENCE AND IDEOLOGICALLY-MOTIVATED VIOLENT EXTREMISM

RCMP SPEAKING POINTS:

- The RCMP continues to work closely with domestic and international law enforcement partners as well as the security and intelligence community to analyze and assess criminal threats and activities.
- The RCMP investigates persons who are suspected of being engaged in criminal activity, including offences related to terrorist entities, under the National Security and Terrorism mandate. Our investigations target criminal activity of any individual(s) who threaten the safety and security of Canadians.
- In terms of ideologically motivated extremism, the RCMP and domestic partners continue to investigate certain individuals and groups who have been using the COVID-19 pandemic to spread propaganda, exacerbate social tensions, encourage criminal or violent actions, and undermine trust in public institutions and government.
- ~~We know that much of the extremism identified in the protests has been fomented from misinformation and propaganda that has gone largely unchecked through social media and other online platforms.~~
- We maintain close partnerships with CSIS and other domestic and international security and intelligence agencies, and engage in tactical information sharing with foreign partners to counter IMVE threats.
- Given there is often overlap between hate-motivated crimes and IMVE-related criminality, the RCMP works closely with police of jurisdiction to identify criminal threats of national security interest and conduct coordinated investigations.
- Rest assured, we will respond, with our partners, in an appropriate manner based on what our intelligence tells us.

Question: What did the RCMP see going into the blockades?

Answer:

- At this time, I am not able to release any specifics related to any ongoing investigations.
- That said, I can assure you that the RCMP continues to maintain situational awareness of the threat environment with due regard for any threats with potential national-level public safety implications.
- In terms of what we've been seeing over the past several months, from a law enforcement perspective, we have noted, across the country, an escalation of tensions and public opposition to federal and provincial government responses to the current pandemic.
- Much of the public opposition has manifested itself in a lawful manner, however, we have seen instances of criminal activity and have taken appropriate enforcement action in those situations.

Question: Has the RCMP seen any indication of IMVE or extremists?

Answer:

- The RCMP takes the threat from Ideologically Motivated Violent Extremists very seriously.
- We are aware that IMVE groups are present and have supporters in Canada.
- We also recognize that individuals who are motivated to commit violence may be previously unknown to law enforcement
- While I cannot comment on any operational matters or provide details on specific investigative targets, I can say that, collectively, we have robust measures in place to detect and disrupt threats to public safety or Canada's national security posed by IMVE threat actors.
- The RCMP will investigate and, wherever possible, lay criminal charges against individuals who seek to carry out acts of violence.

Latest Data (estimates):

- Convoys totalling approximately 2950 vehicles have arrived in the NCR.
- Unknown number of vehicles in the downtown core.
- Approximately 30 people reported at this time on Parliament Hill and approximately 50 people on Wellington St.
- New lumber truck with scraps of 2x8's, at times trucks are five wide, blocking intersections.
- A FB video posted at approximately 6:15PM, shows Rideau Rd., is blocked by trucks.
- OPS still experiencing flashpoints at various intersections in the downtown core and traffic continues to be significant. Congestion on bridges has improved.
- Alexandra and Portage Bridges remain closed; Chaudiere Bridge southbound is closed; MacDonald Cartier has reopened to 2 lanes in each direction; Champlain Bridge remains open.
- Rideau centre remains closed today due to issues yesterday surrounding protestors entering the mall in absence of complying with COVID measures.
- Coutts, Alberta: The POE in Coutts, AB continues to be impacted by a convoy protest. Alternate crossings have been opened, however, it is anticipated that it will take some time before the convoy is cleared and traffic is rolling smoothly. While the organizers have asked

that people cooperate, some are not following the organizers requests. It is estimated that there are approximately 800 people at the POE.

Convoy Overview:

- The demonstration is comprised of 3 "Freedom Convoys", one from Western Canada, one from Eastern Canada and a third from Southern Ontario.
- The goal of the nation-wide protest is to disrupt traffic flow and general business of government in the hopes that the Canadian government will lift all COVID-19 related restrictions.
- Key timelines as of right now are as follows:
 - January 30*
 - 11:00 AM: Church service on Parliament Hill led by Pastor Henry HILDEBRANDT; March from 1 Nicholas St. to Parliament Hill led by PPC leader Maxime BERNIER.
 - 12:00 PM: The leader of the People's Party of Canada (PPC) speaking on Parliament Hill.
 - Afternoon: Press Conference by organizers (event time and location TBD).
 - In a Facebook video, the Farfadaa group was observed at a peaceful protest in Hull at approximately 1:00 PM. At approximately 3:30 PM, a Facebook live stream of the Farfadaa group began which shows the group walking North on Maisonneuve. They stated that they have to do a detour and that they negotiate when they want. They stated since the police would not negotiate they would speak to the RCMP.
 - PPC leader BERNIER
 - January 31*
 - According to the Canada Unity website, on January 31st, the group will begin hosting a speaker event at Confederation Park.
 - OPP PLT have reported chatter that the end of the event could be February 2, 2022. Many of the commercial vehicles on the Sir John A MacDonald parkway also mentioned they want to leave due to a lack of fuel. It is unclear if they would return.
 - PPS advised that concrete reinforcement blocks have been added to No Name St. New concrete reinforcements have also been added in front of parking "850" beside Supreme Court.
 - OPS reports that George BILLINGS is handing out a flyer titled "FREEDOM CONVOY 2022 Registration Form", which appears to be the process upon which participants can register to be compensated for their involvement. Form lists the following email for submission: financeconvoy2022@protonmail.com
 - PPS received an application for a permit in support of a riser that will be installed for 2 days. Application was submitted by organizer of 'Adopt a Trucker' fundraiser.
 - Speakers have been set up in front of Queen's Gate.

- SQ advises that Ottawa Churches are opening up their doors to accommodate individuals who have nowhere to stay this evening, and also advises that almost all downtown Ottawa restaurants are closed this evening, which limits where people will be able to eat (Jan 29).
- NCRCC has confirmed that, despite bridge closures, anyone needing to get to work from QC (first responders, health care workers, law enforcement) can show their work ID/badges at the Chaudiere Bridge and gain access to the NCR through Booth St.
- Trucks are trying to get around the City of Ottawa heavy vehicles that are blocking roads downtown.
- Alexandria and Portage bridges remain closed to traffic coming into the NCR.

Solidarity Protests:

- In solidarity of the main convoy, demonstrations may take place at Federal buildings across Canada: Victoria, Legislative Assembly, Vancouver, Canada Place, Calgary, Prince Island Park, Edmonton, Legislature building, Regina, Legislative building, Winnipeg, The Forks, Toronto, Union Station, Montreal, Place des arts, Moncton, Riverfront Park, St John's, Harbourside Park.
- CBSA Updating on Ports of Entry (Jan 29):
 - Woodstock: As of 1:00 PM, more personal motor vehicles have arrived at the Woodstock Rd. POE. Fewer than five (5) vehicles, however, are blocking one of the southbound lanes to the US. One lane remains open to commercial motor vehicles. Incident command has negotiated with the Canadian protestors, who will allow commercial motor vehicles to pass through into the US. No personal motor vehicles would be permitted through the protest location. US CBP has advised that as of 2:15 PM, there are no protestors remaining on the US side and outbound lane checkpoint has been dismantled. Remains very peaceful.
 - 7:02 AM: A truck convoy had assembled North of the Emerson port of entry. Approximately 100 commercial vehicles are participating. All four (4) lanes of Highway 75 appear to be occupied.
 - As of 11:54 AM, group of 100 vehicles reported protesting on Huron Church Rd. in Windsor, ON, near Ambassador Bridge POE. No impact on border traffic and no reported activity on the US side of the border.
- "Slow roll" convoys at provincial and Canada/U.S. border crossings are being planned over the weekend.
- **BC:**
 - Terrace, BC: Approximately 150 passenger and commercial vehicles participated in a peaceful rally that was held yesterday.
 - Planned protest on January 29th in Terrace, BC. An estimated 200+ vehicles are expected to participate and the planned route is being shared on the following Facebook Group 'Bear Hug 4 Bear Hug'.
 - Osoyoos: Convoy departing at 8:00 AM PST traveling to Vernon, with a plan to then return back to Osoyoos, stopping at Town Hall at 1:00 PM PST and then at the Osoyoos Port of Entry (Canada/US Border) at 3:00 PM PST.

- Vernon:
 - At 9:30 AM PST, approximately 50 vehicles gathered on the weigh scale north of Vernon on Hwy 97. Convoy departed shortly after towards Kelowna, BC.
 - A large group of approximately 300 people gathered at the intersection of Hwy 97/25th Ave. at 12:00 PM PST and fully dispersed at 2:00 PM PST.
- Fort St. John, BC: “Freedom Rally” caused significant delays between Dawson Creek and Fort St. John and complaints from the public were received. Rally finished at the Charlie Lake site with a BBQ for the participants. Members estimated 300 vehicles were involved in the rally.
- Lower Mainland:
 - On January 29th at 11:00 AM PST, a planned rally began at Memorial Peace Park. Attendance was estimated at 125-150 individuals. Speeches were delivered and the group began their march at 11:30 AM PST. During the march, minor traffic disruptions occurred. Once back to the park, the group dispersed and traffic flow is no longer an issue. Event was peaceful.
 - At 10:00 AM PST, people started gathering at the Lickman Overpass in Chilliwack, BC. By 1:00 PM PST, the group had grown to 500 people, lined up on both sides of the overpass. At 3:00 PM PST, there were over 1000. Crowd began to disperse at 5:00 PM PST and it is estimated that over 6000 vehicles would have passed through from the time the gathering began. Event has now concluded.
 - Protests are also being planned in Lumby and Vernon.
- **Alberta:** Traffic to and from the Canadian side of the border crossing at Coutts, Alberta is completely blocked. There is a jack-knifed semi truck (reinforced with other vehicles) blocking the northbound lane of Highway 4. On the Canada side, the RCMP shut down access to Coutts last night January 29th as the traffic is snarled and will take a long time to get it moving. Jack knifed trailers (multiple), more trucks against them, tow truck operators as part of the protest. Only one heavy tow truck operator is working but it takes hours to clear just one truck. The organisers have asked for people to cooperate, however, the ‘people’ are not following organisers direction. There are splinter factions and some are quite militant. There are over 800 people at the location with many innocent bystanders caught up in this. (Jan 30 at 12:05PM). The dialogue between the participants and the CCMG has degraded. We are not able to direct traffic to an alternate border crossing. Social media posts have been put out from the Alberta RCMP Twitter and Facebook accounts for public safety.
- **Manitoba:** CBSA reporting protest at the Port of Entry in Emerson, MB. In addition, there are Support Freedom convoys in the Emerson, MB and Headingley, MB areas. Convoys consist of a significant number of vehicles are causing traffic disruptions. Emerson convoy involves approximately 100-150 vehicles (6km in length) and activity involves a slow roll 2-mile continuous loop along Hwy 75. The Headingley convoy is over 40km in length and is making its way towards Winnipeg, MB. No significant issues, outside of the disruption of traffic flow.

- **Ontario:** A slow roll to cause disruption is planned for January 29th in Sault Ste. Marie area.
- **New Brunswick:**
 - Convoys from B, H and L division have joined together in Aulac, New Brunswick. J Division CP/DEOC went to Level 1 and on January 29th, and went to level 2 (until midnight), to manage four events: NS/NB border Protest, NB/Maine Port of Entry Protest, a private vehicle convoy from NE NB, and a severe winter storm. Blockades occurred but did not last longer than 1.5 hours due to severe weather deterioration. Information received that there will be a 'slow roll' in St. Stephens, NB on January 30th. This is another POE from NB into Maine, USA.
 - Information has been received suggesting multiple protests being planned throughout the province for 2022-01-31 with the potential to impact critical infrastructure.
- **Nova Scotia:** As of 08:00 AM on January 30th, Hwy #104 has reopened. The small group of protestors on the NB side, has decided to return to their communities. Protestors in Amherst have also returned to their communities. An application has been made for street closures in the Town of Shelburne and areas, to support the 'slow roll' of vehicles through an approved route.
- **PEI:** A convoy plans to begin a slow roll demonstration at 01:00 PM EST on January 29 from the By-Pass and University Ave intersection down University Ave to the Cenotaph before dispersing.

Operational Planning:

- Given the multi-jurisdictional impacts of this large scale demonstration on the NCR, all key stakeholders (RCMP, OPP, OPS, PPS, SQ, MRC des Collines, the City of Ottawa, Ville de Gatineau, SPVG) are actively planning and collaborating to ensure public safety.
- RCMP, in collaboration with PPS, are in the process of activating drone mitigation protocols, to support detection requirements.
 - At 1520hrs, a professional drone was located near West block. POCC advised they identified the owner of the drone and the subject is linked to drone incident during the election. (Jan 30, 3:40pm)
 - Another drone, with no apparent connection to the above-noted drone was spotted near West block. The drone is currently in flight. (Jan 30th 5:40pm)
- PPS advised that concrete reinforcement blocks have been added to No Name St. New concrete reinforcements have also been added in front of parking "850" beside Supreme Court.
- As long as protestors remain peaceful, they will be able to exercise their democratic rights to protest. Should this extend into several days, whereby undue disturbances are caused to the public and downtown core, judicial authorizations to forcibly remove trucks and protestors may be considered. The City of Ottawa, OPS, and Ottawa Legal Services are currently exploring all legal options, which includes injunctions.
- Using force to remove the truckers and protestors will be considered as the last resort. The preferred strategy is to wait it out, with truckers and protestors egressing willingly.

- RCMP Senior Management has declared these events as being ‘Extreme circumstances’ to facilitate the ability to access resources on short notice, in the event that surge capacity is required to support a prolonged event. NPF have been consulted and are supportive.
- January 30, 2022 at 11:32, a communiqué was distributed confirming the declaration of this event as an “extreme circumstance”, in accordance with Section 21.28 of the RCMP Regular Members (below the rank of Inspector) and Reservists (RM) Collective Agreement. Therefore, should it be absolutely required, members redeployed under the temporary National Division command may exceed their maximum allotted hours of work until resource replacements or relief arrive.
- RCMP surge capacity currently stands at over 100 members in the NCR, inclusive of C Division (40), National Division, Ottawa Detachment and National Headquarters. Additional surge capacity has been identified by C Division (50) and O Division (40), who are ready to deploy to the NCR, if required.
- The RCMP has asked Transport Canada to temporarily expand their standard NOTAM over Parliament Hill as part of their plan for managing the scene. They have issued a temporary NOTAM for the additional space not covered by the permanent restriction over Parliament.
- PPS has advised that the 100 public order resources (from OPP and RCMP O Division) will be located within Westblock, in the event that they are required.
- MLT working with PPS to distribute a message to Ministerial Chiefs of Staff requesting information on which Ministers plan to attend Parliament on January 31st, along with arrival/departure times. This will assist in scoping out sequencing and routes.

- The **National Capital Region Command Centre (NCRCC)** will be activated as of 8:00 AM on January 28th, through to at least January 30th.
- All key internal and external stakeholders will have a presence in the Regional Command Centre to ensure ongoing communication and collaboration. While the NCRCC will also serve as the area command centre for the RCMP, forward command centres are being stood up at alternate locations by OPS and PPS with direct linkages into the NCRCC.
- In addition to domestic partners, a representative from the US Embassy will be in the Command Centre given the potential impacts on that diplomatic site.
- The Ottawa Police, and PPS, with support from the OPP have a vehicle screening process for the downtown core, and can support up to 3000 vehicles for inspection.
- The 2 lanes surrounding Parliament are controlled at sites on Kent and Bank Streets, with mobile command centers set up. (POJ and PPS)

- Given the resumption of Parliament scheduled for January 31st, contingency plans are being developed to ensure supplemental resources are available and to minimize the potential for ongoing disruptions.
- The RCMP C Division helicopter has been made available for 24/7 usage and Transport Canada has offered up a helicopter, should it be required.
- SPVG have advised that the Alexandria Bridge will be closed as of 6:00 PM on January 28th.
- GOC sent out an email to the CSO/DCSO community advising that they have received confirmation surrounding protestors entering office buildings in the downtown core and allegedly causing damage. As a result, Minto Place, is going into weekend lockdown mode, effectively immediately.
- PSPC is working in close collaboration with the Parliamentary Protective Service to coordinate activities specific to the parliamentary precinct, such as providing barricades and access to infrastructure as required during the event.
- As a precautionary measure, and following recommendations from security partners, PSPC has authorized the lock down of all buildings under its control (100 Wellington, National Press Building, etc.). Access for essential building occupants will be maintained at all times.
- Jersey pillars have been placed on the perimeter of the War Memorial.

Public Order:

- The **Parliamentary Protective Service (PPS)** is the planning lead for the **Parliamentary Precinct and the grounds of Parliament Hill**.
- For Jan 31: PPS will be maintaining their current posture (PPS resources, not static, fluid and can be deployed based on situation and threat/risk). This DOES not include the Public Order Unit support (150-200 OPS/OPP and 50 RCMP TSG).
- The **Ottawa Police Service (OPS)** is leading the planning for the **National Capital Region**.
- **National Division** is planning in support of the RCMP's **protective mandate** and working to ensure that we support our law enforcement partners in the region with any specialized support services required.

RCMP Protective Mandate:

- The RCMP's role is to maintain Protective Policing core VIP duties at all times.
- Following a message from the SAA to MP's regarding the publication of addresses online, the RCMP has received a vetted list of MP's residing in the NCR. The next step will be to develop a visualization map of these residences and consideration is being given to utilizing surge capacity resources proactively, deploying them in teams to increase patrols in the areas.
- PPS and Protective Operations are ironing out the details surrounding advances to Westblock, in order to plan for the resumption of Parliament.
- PPS has been advised that 175 MPs and 20 Ministers plan to attend Parliament on January 31st. A call was held at 3:00 PM January 29th between PPS, RCMP (Protective), RCMP (MLT), PCO, and PSPC to discuss ingress and egress into the downtown core. Key highlights include:
 - RCMP, PPS and SAA to work together on arrivals and departures.
 - Some will be on foot and some via vehicles. MLT message will help with sequencing.
 - Speaker Roda and Official Opposition Leader O'Toole to be considered as part of the Ministerial packages.
 - PPS is working with the WHIP's offices. They will be flexible to any plans including the possibility of an earlier than normal start to the day.
 - PSPC is engaged should further fencing etc be needed.
 - .
 - Planning is ongoing with another meeting the morning of January 30th.
- Using force to remove the truckers and protestors will be considered as the last resort. The preferred strategy is to wait it out, with truckers and protestors egressing willingly.
- Regarding the resumption of Parliament, in anticipation of protests continuing, our Ministerial Liaison Team is working with PPS to determine which Ministers plan to attend Parliament tomorrow, along with arrival and departure times. This will assist in scoping out sequencing and routes.

- The RCMP reached out to the all Ministers and Official Opposition leader's offices. Sixteen provided the time they intend to go to Parliament Hill and so far four have requested a driver and body guard (as of 5PM Jan 30).
- MPs will be provided information from the SAA or PPS regarding how to access Parliament Hill. They will coordinate with the RCMP escorts as required to help MPs arrive safely. The RCMP will be prepared to drive or walk MPs to Parliament Hill where PPS will ensure access onto the grounds is maintained.
- It is expected that many will simply walk and that anyone planning to drive (including the RCMP) will face challenges.
- The acting Director of PPS scheduled a meeting Jan 30th at 5:00PM with representatives of RCMP, SAA, PSPC, HoC and OPS to discuss the egress and ingress plan for tomorrow.

- January 28th: RCMP, OPS and PCO Chief Security Officer held a call at 4:30 PM with Ministers Chiefs of Staff to provide an update on the demonstrations. Roughly 40 people participated in the call. The following questions were raised with the associated responses provided:
 - What if the demonstrations extend past Sunday, plan for the return to Parliament on Monday? OPS has robust plan in place to ensure ingress and egress to Parliament Hill. National Division can assist with the escorting of Ministers, based on threat and risk. OPS PLT continue to work closely with organizers and the relationship remains positive. PPS has been stood up to hold to the fact that this could extend into next week.
 - Threat level at airport and plan for escorts to downtown core, given multiple Ministers will be arriving into the NCR on January 30 and 31? OPS indicated that there are no indications of threats towards YOW. Recognizing that 30 Ministers are scheduled to arrive on January 30, the RCMP will be conducting advances to the airport and can provide threat based escorts to Ministers.
 - Protection for Ministers who have been vocal about convoy? Corporate Security at the House of Commons works closely with the POCC and PPS to ensure the safety and security of all Parliamentarians. Awareness pieces have been provided. If security issue, direction is to call 911 and then report it into the SAA of the House of Commons. Any issues of criminality at constituency office should be reported to the police of jurisdiction, if uncertain, call SAA, can provide advice and will liaise with POCC, to facilitate or to provide support required.

- PPS advised [REDACTED] reportedly told members at the Elgin Gate, “you lost control, get ready”. They were observed walking west on Wellington St. PPS and OPS working to locate these members and reviewing CCTV footage.

OPS:

- OPP reports that a demonstrator has collapsed in front of the stage on Parliament Hill. Medic is on route and police are on the scene.

- OPS has advised that, in addition to the larger demonstration in the downtown core, organizers are planning additional events on January 29th and 30th in Confederation Park.
- OPS has advised that Confederation Park will be used as the home base for some participants. This includes the installation of tents, food vendors (2 trucks) and a BBQ in the Park.
- An active plan for the demounting of truck trailers has also been established by the OPS.
- OPS COT overheard a group of demonstrators talking about a PC parked at the Chateau Laurier. Comments were made that the cruiser was there to entice them. The cruiser has since been moved.

RCMP National Division:

- National Division's Critical Incident Program (CIP), which includes the Protective Operations Response Unit, Emergency Response Team, Tactical Support Group, Crisis Negotiation Team, Critical Incident Commanders, Scribes and the Tactical Paramedic Unit are actively engaged in the planning process.
- Ottawa INSET investigating matter regarding a threat to bomb Parliament Hill, the source of the threat appears to be in [REDACTED] ON. Toronto INSET has been engaged.
- The staging of RCMP public order resources and any other specialized operational support from the RCMP will be done in a discrete manner. At this time, we have not received a formal request for support from PPS or OPS, however, it is expected that these requests will be forthcoming as interagency planning evolves.
- The NPF has engaged National Division and has expressed support with the planning and communication efforts that have taken place to date. They have been invited to attend the NCRCC at any point during its activation.
- The RCMP is on standby to deploy any additional tactical troop or additional kinetic nature emergency dealings if required.

Intelligence and Open Source:

- On January 30, 2022 at 1855hrs, Freedom Convoy 2022 organizers held their first live video conference. Very little engagement, around 100 views with no comments.
- A post on [REDACTED] channel identified Dr. Theresa TAM's condo address.
(more details below in MINISTER's section).
- Romana DIDULO, the self-proclaimed Queen of Canada has posted on social media that she is travelling to Ottawa and scheduled to arrive on February 3, 2022 to support.

demonstrators.

- PPS-PI observed a discussion between [redacted] (timestamp 1850 hrs). [redacted] mentions heavy police presence on Parliament. [redacted] talks about Antifa “coming to try and pick fights with stragglers from the crowd”. [redacted] states that Parliament resumes tomorrow “so cops are looking for an excuse to remove truckers/patriots from the capital.” [redacted] calls to “HOLD THE LINE!” [redacted] states “All eyes are on you king.”
- Information on [redacted] was reported, claiming that a car and trucks had driven through a barricade at Albert and Elgin, but information was unfounded. OPS confirmed that a car went through barrels on MacDonald Cartier Bridge and that the vehicle was stopped at Albert and Elgin.
- CIG OSINT observed a Facebook video of [redacted] posted at 6:03PM. The 1:48 minute video shows [redacted] on a sidewalk in front of Parliament Hill entrance. In the video [redacted] mentions having fun. Mentions he does not drink but hooked up an old guy with a joint but still has half of it in his pocket. [redacted] talks about walking around downtown Ottawa with a camera and ‘going to have some fun’. [redacted] asks for intel and tells the “idiots up there” going to the war room to smarten up or they are going to get people killed.
- On [redacted] the user [redacted] is telling people on the ‘convoy to Ottawa’ not to follow police instruction and to head downtown, otherwise you will be redirected outside of the city. The user [redacted] responded to [redacted] that truckers should spread out and head to other towns instead of Ottawa.
- The Farfadaa group posted a Facebook live stream at 3:30PM, which shows the group walking on Maissonneuve towards Northbound. They stated they have to do a detour and they negotiate when they want. Since the police would not negotiate, they would speak to the RCMP. (Jan 30 at 3:40pm) NOTE: earlier in the day, the group comprised of approx. 300 when they were on the Portage Bridge.
- PPS PI reporting:
 - Canada First affinity group has entered onto Parliament Hill, including POI’s [redacted] and [redacted]
 - POI [redacted] POI [redacted] a group denoted by [redacted] multiple red flags with white ‘CF’ logo.
- There continues to be significant online chatter to locate PM TRUDEAU’s current whereabouts. This includes a Twitter post identifying a plane flying near Harrington Lake on Saturday night. Flight tracking services confirmed the flight information. No concerns identified by the CIG at this time. (Jan 30th at 10:57 AM)
- PPS members reported a suspicious incident near Valour building, male with [redacted] : was spotted on Sparks St. and was observed to be looking in windows, doors and at rooftops.

- A Facebook user shared a video and images from a small plane (approximately 15hrs ago). The plane appeared to be circling the downtown Ottawa area. According to the post caption, the pilot flew from Syracuse, NY. Unknown at this time if this individual plans on flying over the Ottawa area today.
 - A Twitter post identified a plane flying near Harrington Lake (January 29th at 10:00 PM). OSINT has confirmed the flight record on a commercial flight tracking service (FlightRadar24). The airplane tail number is unknown, as information appears to be blocked. Flight tracking service reports that the plane flew near Harrington Lake at 0304hrs UTC (10:04 PM EST) at an altitude of 3,000ft and ground speed of 90kts.
 - According to a Facebook live video posted at approximately 0958hrs on the Canada Unity Facebook page, SOI Jason LEFACE
LEFACE is advising participants that there might be delays to the church service that was planned on Parliament Hill for 1100hrs, as the group's microphones have been stolen.
 - SPVG reporting that SOI Steve L'Artiss CHARLAND currently delivering a speech and is blocking the Portage Bridge.
 - Daniel BULFORD, a recently resigned RCMP National Division and leads the Mounties4Freedom group, is organizing the volunteer security for the group warroomcanada.net which involves the task of reception and hosting the truck convoys converging in Ottawa.
-
- OS research reveals significant public criticism directed at convoy organizers (Tamara LICH, Pat KING, and BJ DICHTER) due to their past associations to extremist groups.
 - Second hand information received that BMR in Smiths Falls, ON received an order for 4 pallets of bricks to be delivered to downtown Ottawa. Order was cancelled.
 - Recent Twitter posts suggest piles of bricks being left around Ottawa, likely downtown area. Possible that the group was able to fulfill their order elsewhere.
 - OPS found OSINT information indicating that there are calls from a group (Trucking for Freedom) to upload footage to truckingforfreedom.com in order to create a documentary about the Convoy Freedom movement which began in Canada in January 2022. The group claims that they will be 'releasing an official documentary on this historic Canadian event' and are soliciting the help of videographers, photographers, drone pilots, or 'passionate Canadians' for their footage.

- OPP advised that the PLT spoke with the leader of Canada Unity, [REDACTED] who expressed that no one was leaving and that more convoys will be coming from the US and West. He also advised that his 'executive board;' were all together at the [REDACTED] which is their 'command center'. Nothing to corroborate at this time. Their goal remains unchanged in that they want to ensure that everyone who has come for this movement get into the core and they are now mobilizing for this to happen. Looking to engage the NCR police services in what he called a 'risk mitigation meeting'. Information regarding this request of was shared with OPS.
- Former POTUS Trump spoke at a rally in Conroe, TX and mentioned the Canadian truckers. A Tweet posted at 9:01 PM states "President Trump sends a message to the Canadian truckers: 'We are with them all the way!'" A video is linked to the Tweet. In the video, Trump says: "The Canadian truckers, you've been reading about. Who are resisting, bravely, these lawless mandates are doing more to defend American freedom than our own leaders by far. And want those great Canadian truckers to know that we are with them all the way. They are.. they've really shown something.". The video has been viewed 27.4k times.
- PPS advise that [REDACTED] live stream signals out of a Ryder cube truck. [REDACTED] is monitoring the events occurring on Parliament Hill.
- Continued uptick on social media about Harrington Lake, following the release of news articles that the PM has left Ottawa.
- CS-SAA advise that Ontario MPP Randy HILLIER wrote on a Tweet "I call on PPS to completely open Parliament Hill, or we might have to open it for ourselves." In the video, HILLIER is seen moving a barrier and encouraging people to move past it. PPS blocked the area so that people can not access it.
- Fireworks currently being set off on Parliament Hill.
- PPS advised [REDACTED] reportedly told members at the Elgin Gate, "you lost control, get ready". They were observed walking west on Wellington St. PPS and OPS working to locate these members and reviewing CCTV footage.
- Counter demonstrators are now present, expressing support for vaccines. This has the possibility of creating tensions.
- Reports of fires being started behind National Archives and in front of Supreme Court. Ottawa Fire is looking into it.
- Gadsden flag observed on Parliament Hill.
- Truck with flag carrying propane tank was spotted at the corner of Bay St. and Queen St.
- Security and intelligence partners continue to look in social media post referring to truck ramming gates.
- Centennial Flame is no longer lit, was extinguished, standard part of PPS operational planning when large scale event on the grounds of PH.
- Rideau Centre is closed due to non-compliance with COVID-19 measures.
- Drone spotted in the area of Parliament Hill.

- Sighting of a black flag depicting the Punisher’s logo, resembles the flags deployed on January 6, 2021 by members of The Proud Boys, the Oath Keepers and unaffiliated rioters.
- In Facebook video, SOI Patrick KING is observed saying the following:
 - KING offers food, showers and washrooms, at the Holiday Inn (402 Queen St., Ottawa, ON) for people that are gridlocked;
 - They are working on getting fuel for trucks and/or getting the trucks to fuel stations;
 - They are working on logistic for portable toilets;
 - Claims that OPS is not well organized and they are on the “backfoot” with trucks scattered all over downtown;
 - Claims that there were 1.4M people in the city;
 - That the media is lying;
 - KING says he has friends with sliptanks that they can use to refuel; and
 - Nobody is going anywhere; trucks won’t be moved. PPOI

- OPS member spoke to [REDACTED] regarding his open carry knife.

- OPP Intelligence reported a Facebook video of George BILLINGS stating that “...come nighttime when these cops gotta sleep, that’s when we’re gonna move because they don’t got nothin’ like we got.” In his video, he also states that “Monday is the big day, we all go to work – when does everyone work? Monday.” (Jan 30 5:40pm)
- GIG OSINT located a Facebook video on ‘The Real Pat King’ page. In the video, of interest, he says he is heading to a meeting in the ‘war room’ to start working with officers on getting these trucks moving.” and “We are not moving, we are not leaving, we need to coordinate.” He states he is trying to be police and nice and work with everyone. Similar to BILLINGS’ video, eludes to the fact that they are just getting started.
- On [REDACTED] users have mentioned that more trucks are coming from Quebec. Discussions that the military would be in Ottawa to “clean up”.
- On January 30, 2022 at 6:50pm, during a discussion, [REDACTED] talks about Antifa coming to try and pick fights in the crowd and states that Parliament resumes tomorrow but calls to “HOLD THE LINE!” (Jan 30th, 7:40PM)
- CIG identified live feed on Facebook from Pat KING and are monitoring. In a video posted last hour, KING is observed in front of PMO offices, knocking on the door and stating “Hey Justin, are you home?”.
- Jeremy MACKENZIE (F / H Division) who has issued threats against the PM online and recently arrested on weapons charges is in the NCR. Jeremy MACKENZIE posted a video at 1315hrs on [REDACTED]
